

**EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG)  
ANTI-DRUG ABUSE (ADA) PROJECT SUMMARIES**

**Alameda County Sheriff's Office - \$583,591**

This project is a multi-jurisdictional narcotic task force composed of representatives from local law enforcement, prosecution and probation. The task force will work collaboratively to target, investigate, arrest and prosecute mid to major level traffickers of narcotics and dangerous drugs. This coordinated effort involves all major components of the criminal justice system: Law Enforcement will focus on the investigation and apprehension of drug dealers; Probation will assist in the investigation and apprehension of drug-related probation violators; Prosecution will manage the project's cases from start to finish by providing training, legal advice and final disposition. Assistance will also be provided by the Alameda County Behavioral Health Care Services in analyzing county-wide trends and problems.

**Alpine County Sheriff's Office - \$85,582**

Based upon the remote demographics of Alpine County, the Alpine County Narcotic Unit's (ACNU) mission and primary focus is to aggressively investigate manufacturing, trafficking, sales and use of narcotics within Alpine County. ACNU will coordinate with surrounding agencies to identify and investigate suspects responsible for the transportation of narcotics into Alpine County.

ACNU will be comprised of one Lieutenant, Project Director, and two Detectives employed by the Alpine County Sheriff's Office; the Alpine County District Attorney's Office; the Alpine County Adult and Juvenile Probation Office; the Alpine County Health and Human Services – Child Protective Services; and the Alpine County Drug and Alcohol Counselor. Funding for these positions is as follows: The Project Director and one Detective will be funded 100% by this grant. The District Attorney, Probation, Child Protective Services, and the Drug and Alcohol Counselor will be funded by the general fund.

**Amador County Sheriff's Office - \$92,202**

The Amador County Combined Narcotics Enforcement Team (ACCNET) task force is comprised of members of law enforcement agencies in Amador County focusing on intelligence gathering, identification and disruption of illegal sales, manufacturing, and trafficking in Amador County. The task force is comprised of police officers, deputy sheriffs, a CHP officer, a D.A. investigator, an agent with the Department of Justice, and an investigator with the California Department of Corrections and Rehabilitation. This multi-agency collaborative approach is proving successful in reducing the impact of illicit drugs within Amador County by targeting manufacturers, dealers, and traffickers. These criminals negatively impact the quality of life for residents of Amador County. Additionally, many violators reside in contiguous counties and either sell to Amador County residents, who transport the controlled substances back into Amador County or they traffic their controlled substances into the county for sale.

**Butte County Probation Department - \$135,447**

The Butte Interagency Narcotics Task Force (BINTF) is a comprehensive and collaborative multi-agency response to the enforcement of narcotic and controlled substance laws of the State of California in the County of Butte. BINTF will be primarily dedicated to identifying and investigating drug manufacturing and sales, which affect the entire county. BINTF will improve public safety through the reduction of clandestine drug manufacturing, and conducting

investigations involving street-level drug dealers, including gang members. BINTF will identify and arrest violators placing children at risk in drug-related environments and rescue children from drug environments.

#### **Calaveras County Sheriff's Office - \$91,788**

The Calaveras Narcotics Enforcement Unit (CNEU) has been in operation for over twenty years. CNEU is a multi-agency anti-drug unit that enforces controlled substance laws in the State of California using a cooperative and collaborative approach. CNEU is composed of members of the Calaveras County Sheriff's Office, the District Attorney's Office, and the Office of Child Protective Services. The Calaveras County Sheriff's Office is the lead implementing agency.

#### **Colusa County Sheriff's Office - \$89,596**

The Colusa County Narcotics Enforcement Team (COCONET) works as a multi-agency unit and is overseen by the Task Force Advisory Council. COCONET works criminal cases against people involved in the sale, use and transportation of narcotics. The main goal of the task force is to target street-level and mid-level drug dealers.

The probation component works under the probation drug specialist strategy and will coordinate and perform drug searches and testing. The prosecution component assists in the prosecution of cases and processes all seizures referred to them for asset forfeiture. All task force agencies have made a commitment to work together to accomplish the units goals and objectives.

#### **Contra Costa County District Attorney's Office - \$354,515**

The Task force will focus on identifying and prioritizing target offenders in the entire county and adjacent area. The Crime Lab, District Attorney's Office, and Probation Department will support the activities by assisting in enforcement operations, conducting speedy analysis of seized controlled substances, pursuing aggressive and timely prosecution of offenders, and maintaining close supervision of those who receive probation.

#### **Del Norte County Sheriff's Office - \$90,659**

The Task Force works with other local law enforcement, including the Del Norte Police Department and the California Highway Patrol. Members from other local agencies, including Health and Human Services, Child Protective Services, and the Emergency Department at the local hospital, fully support our County Drug Endangered Children Protocol. Our agreement with the Smith River Rancheria also pays the full cost of one of our Task Force deputies joining our fight against drugs. This Law Enforcement unit will work criminal cases against people involved in the sale, use and transportation of narcotics. The main goal will be to target street-level and mid-level drug dealers. The second goal will be education. The probation component will work as if under the probation drug specialist strategy. They will coordinate and perform drug searches and testing. The prosecution component will assist in the prosecution of cases and process all seizures referred to them for asset forfeiture. The Task Force and above mentioned agencies have made a commitment to work together to accomplish the goals and objectives.

#### **Fresno County Sheriff's Office - \$361,951**

The Fresno County Narcotics Enforcement Team (FCNET), in joint effort with the Fresno County Probation Department, and the Fresno County District Attorney's Office, plans to reduce and prevent illegal activities of targeted narcotics offenders by conducting special investigations in and throughout the County of Fresno. The FCNET works with and maintains a close working

relationship with members of the Drug Enforcement Administration (DEA), Homeland Security Investigations (HSI), High Intensity Drug Trafficking Areas (HIDTA), and other local and nationwide law enforcement agencies in order to share and complete thorough narcotics investigations.

#### **Glenn County Sheriff's Office - \$89,104**

The Glenn Interagency Task Force (GLINTF) is part of a multi-jurisdictional, anti-drug, anti-gang enforcement task force serving Glenn County and its two incorporated cities. Our efforts are directed at offenders at all levels of the drug environment and culture including major, mid-level, street-level, and gang-related offenders. The main focus of the task force will continue to be the enforcement of Health and Safety Codes through undercover operations, drug testing, arrests, and seizures. We will continue to target major, mid-level, street-level, and gang related offenders. The intelligence database will focus on shared intelligence.

#### **Humboldt County Sheriff's Office - \$116,436**

The Humboldt County Drug Task Force (HCDTF) is the primary law enforcement component of the Anti-Drug Abuse grant program. The HCDTF is supported by seven law enforcement agencies and is now in its 29<sup>th</sup> year of operation. The HCDTF authority and existence is derived by a formal agreement between the Humboldt County District Attorney's Office, Eureka Police Department, Arcata Police Department, Humboldt County Sheriff's Office, and the California Highway Patrol. The HCDTF is under the administrative and organizational structure of the Humboldt County Sheriff's Office and is governed by the Executive Board which consists of the Sheriff of Humboldt County, Chief of the Eureka Police Department, Chief of the Arcata Police Department, Chief Probation Officer, the District Attorney, and the Deputy Director of the Humboldt County Alcohol and Drug Department.

#### **Imperial County District Attorney's Office - \$126,646**

The Special Prosecutions Unit (SPU) is intended to significantly reduce mid-level and street-level offenders' drug trafficking in Imperial County by disrupting their activities and seizing the assets of those responsible for the sale and supply of illegal drugs through intensive investigation, prosecution, and probation supervision.

The law enforcement component, the Imperial County Narcotics Task Force (ICNTF), is a multi-jurisdictional task force, including law enforcement personnel from state, county, city and federal agencies. A commander heads the ICNTF. It is one of the most effective units state-wide in identifying mid-level and street-level drug offenders, and investigating and ultimately referring matters for prosecution to the SPU.

#### **Inyo County District Attorney's Office - \$87,617**

The goal of this project is to continue using a multi-agency collaborative approach to reduce the impact of illicit drugs within Inyo County. This unified effort in Inyo County involving local, state, and federal law enforcement agencies, targets major narcotic offenders and their drug trafficking organizations. This concept allows law enforcement to maximize available resources through a county-wide narcotics task force. The task force concept reduces the duplication of efforts by focusing on source areas and traffic patterns.

### **Kern County Sheriff's Office - \$365,016**

The goal of this project is to continue using a multi-agency collaborative approach to reduce the impact of illicit drugs within Kern County. This unified effort involving Kern County law enforcement agencies targets street-level to mid-level narcotic offenders. This concept allows law enforcement to maximize available resources through a county-wide narcotic task force, the Kern Narcotics Enforcement Team (KNET). The task force concept reduces the duplication of effort by focusing on source areas and traffic patterns.

KNET is currently composed of investigators from the Kern County Sheriff's Office and part-time investigators from the Tehachapi Police Department and Kern County District Attorney's Office. KNET routinely works in conjunction with other narcotics teams, as well as smaller law enforcement agencies within the County of Kern.

### **Kings County Sheriff's Office - \$108,205**

The task force will conduct investigations using information from citizens, and confidential informants, and obtain search warrants to eradicate drugs from the county. When information leads to an operation, records are referenced, warrants obtained, and surveillance conducted. Coordination with other agencies is important to enable the sharing of information and to optimize the use of limited resources necessary to handle investigations.

### **Lake County Sheriff's Office - \$100,511**

The goal of this project is to reduce the impact of illicit drugs within Lake County. In March 2009, the previous multi-agency task force was disbanded when the Bureau of Narcotic Enforcement (BNE) withdrew their task force commander. All law enforcement members of the current LCSO Task Force are LCSO deputies and this is the only drug task force within the County of Lake. The Anti Drug Abuse (ADA) task force deputy is responsible for investigating street- to mid-level drug violations in all areas of Lake County and provides support to all members of the LCSO Task Force.

The LCSO Task Force continues to seek additional members to its ranks and is always open to expansion. The LCSO Task Force continues to provide support to other agencies within Lake County. Its members are currently the only investigators within the County of Lake who are certified to investigate clandestine laboratories. There has been a significant increase in the number of labs being investigated in Lake County.

### **Lassen County Sheriff's Office - \$88,265**

The Narcotics Task Force (NTF) plans to reduce illegal activities of targeted offenders through law enforcement, prosecution, and probation efforts by conducting special investigations. The NTF will work with other federal, state, and local drug enforcement agencies whenever possible, including prosecution and probation departments. The NTF works with and maintains a close working relationship with the members of the Sierra County Sheriff's Task Force. We have a reciprocal agreement with their operation and share personnel and information when needed. Among others, we also work closely with the local CDC Parole unit, the IRS and the DEA in order to complete investigations.

### **LA CLEAR (Monrovia Police Department) - \$810,901**

The Los Angeles County Regional Criminal Information Clearinghouse (LA CLEAR) is a criminal intelligence task force that supports multi-jurisdictional investigations targeting illegal drug

manufacturing, sales, distribution and other Part 1 crimes. LA CLEAR provides logistical support to law enforcement agencies in addressing the whereabouts of recently paroled individuals. The task force partners with other State and national networks and is comprised of law enforcement executives, non-sworn law enforcement, military and contract specialists. The mission of LA CLEAR is to ensure officer safety and operational efficiency by providing advanced technology, intelligence, and enhanced information sharing to all local, state, and federal law enforcement agencies within the LA HIDTA (Los Angeles, Orange, San Bernardino and Riverside Counties) and to other HIDTAs as required. The critical elements within LA CLEAR are: the 24-hour De-confliction Watch Center (War Room); the Analytical Unit which provides case support/research analysis; and the Mission Support group that provides an electronic intercept capability critical to wiretap investigations throughout the State.

#### **LA CHESS (Los Angeles District Attorney's Office) - \$292,162**

The Clearinghouse Electronic Surveillance System (CHESS) is implemented by the District Attorney's Office, with the support of the Los Angeles County Regional Criminal Investigation Clearinghouse (LACRCIC, aka: LA Clearinghouse). The CHESS project provides wiretaps screening by the District Attorney, direct access to LA Clearinghouse investigators for the review of the wiretap clearance and implementation process, vertical prosecution of cases derived from wiretaps, and training to State and local law enforcement officers on the use and preparation of wiretaps.

#### **LA IMPACT (La Verne Police Department) - \$903,340**

The mission of the Los Angeles Interagency Metropolitan Police Apprehension Crime Task Force (LA IMPACT) is to promote coordinated law enforcement efforts and to address emerging criminal justice issues throughout the Los Angeles County area, encouraging maximum cooperation between all law enforcement and prosecutorial agencies, and ensuring the safety of both police personnel and the public, accomplished in an efficient manner within the Constitutional guidelines.

#### **Los Angeles Sheriff's Department - \$430,756**

In 2007, LASD obtained an Anti-Drug Abuse Grant (ADA) and formed the California Multi-Agency Methamphetamine Enforcement Team (Cal-MMET). Cal-MMET is a multi-agency task force, having a day-to-day partnership with the Glendale Police Department, Culver City Police Department, and La Verne Police Department. This partnership provides a team of investigators utilized to target illegal drug traffickers. Examples of these traffickers are methamphetamine manufacturers who produce or sell significant quantities of methamphetamine, including precursor trafficking, within and outside of the Los Angeles County area. Cal-MMET will also target drug trafficking organizations such as the Mexican cartels (groups from the Mexican states of Jalisco, Sonora and Sinaloa) who produce and distribute most of the illegal drugs in the Los Angeles area and throughout the United States. Cal-MMET's ultimate goal is to disrupt and dismantle these drug organizations.

#### **Madera County Sheriff-Coroner's Office - \$116,637**

The task force will have an integrated municipal, county and state participation that disrupts the production, distribution and sales of narcotics in Madera County. Where appropriate, extra-jurisdictional cooperative efforts with outside local, state, and federal law enforcement agencies will be made to further this goal. The team will continue to draw upon various elements from the enforcement community, in particular the Probation Department and the District Attorney's Office.

### **Marin County Sheriff's Office - \$125,360**

The goal of this project is to continue to use a multi-agency collaborative approach in order to reduce the use of illegal narcotics within the County of Marin. This concentrated and unified effort will reduce redundancy and duplication within the county as it pertains to narcotics-related enforcement. This multi-agency approach will maintain crucial relationships that currently exist between the Coordination of Probation Enforcement (COPE) Unit and all of the law enforcement agencies in Marin County.

### **Mariposa County Probation Department - \$87,539**

The Mariposa County Drug Task Force, a multi-jurisdictional collaborative between the Sheriff's Department, District Attorney's Office, and Probation Department, will continue to enforce the state and local controlled substances laws and improve the functioning of the local criminal justice system. The task force will be comprised of an experienced Deputy Sheriff, Deputy District Attorney, Deputy Probation Officer, and Legal Secretary. The Deputy District Attorney will handle all drug cases from filing through disposition. Together, the task force will continue to combat street- to mid-level drug sales, manufacturing, and distribution by adults and juveniles in all communities within the County of Mariposa. Those targeted by the program shall also include individuals who have outstanding drug-related warrants and individuals who are currently on probation for drug-related violations, including Drug Court and Proposition 36 Probation participants.

### **Mendocino County District Attorney's Office - \$99,505**

The Task Force will work toward keeping our communities safe by reducing drug availability and use, by aggressively investigating and prosecuting large-scale drug trafficking and manufacturing, and implementing a full Drug Endangered Children (DEC) program resource for children of drug users and sellers. The target groups are large marijuana growers, manufacturers of controlled substances, and major- and mid-level drug dealers. The Task Force will reduce illegal activities of targeted offenders through law enforcement, prosecution, and probation efforts by conducting special investigations using multi-jurisdictional drug task forces, integrating federal/state/local drug enforcement agencies, prosecution and probation departments.

### **Merced County District Attorney's Office - \$152,636**

The Task Force will reduce illegal activities of targeted offenders through law enforcement, prosecution, and probation efforts by conducting special investigations using multi-jurisdictional drug task forces, integrating federal/state/local drug enforcement agencies, prosecution and probation departments. Arrest and incarcerate those responsible and use state and/or federal law to identify and seize the assets of those responsible for the sale and supply of illegal drugs. Focus on the safety and well being of children by removing children who are found in the presence of clandestine meth labs and other clandestine drug labs and/or who are found in settings involving the use, possession, sale or transportation of illicit drugs, pursuant to California Penal Code (PC) Sections 13879.80 and 13879.81. Hold accountable those individuals who endanger the safety and well being of children by arresting those individuals who willfully create a situation and/or environment where the life or limb of a child may be endangered or his/her health injured, pursuant to PC Sections 273a and 273b.

### **Modoc County District Attorney's Office - \$85,962**

The Modoc County Inter-Agency Narcotics Task Force (MINT) maintains the goal of using multi-agency cooperation, coordination, and collaboration to reduce the impact of illicit drugs in Modoc County. This unified approach leads to local, state, and federal law enforcement agencies to utilize all available resources for focused best use without wasting efforts and resources by duplicating activities and efforts.

### **Mono County District Attorney's Office - \$88,377**

The Mono County Narcotics Enforcement Team (MONET) is a cooperative multi-agency narcotic task force and is the primary narcotic enforcement agency in Mono County. The MONET office is in Mammoth Lakes located in the heart of our most heavily populated community, Mammoth Lakes. The implementing agency is the Mono County District Attorney's Office. The District Attorney is currently assigned MONET cases and utilizes vertical prosecution on MONET generated cases. The Mono County District Attorney's Office is located in Bridgeport, California, 51 miles north of Mammoth Lakes.

### **Monterey County Sheriff's Office - \$185,682**

COMMET and NEUCOM have been collaborating with a newly formed multi-agency county-wide task force known as MAGNT. MAGNT works out of the 10,000 square foot Law Enforcement Operations Center (LEOC) located in the City of Salinas. In addition to individual workspace for all involved, the LEOC maintains a 3-station NC HIDTA wire room, temporary evidence storage, and a state of the art briefing room with SMART board and teleconference capability. Currently the FBI, DEA, ATF, Homeland Security, US Marshals Service, and the ATF are collocated in the LEOC.

### **Napa County District Attorney's Office - \$109,760**

For years, the Napa County Sheriff's Office, Napa County District Attorney's Office, Napa Police Department, St. Helena Police Department, Calistoga Police Department, and Napa County Probation Department have operated a Multi-Jurisdiction Drug Task Force known as the Napa Special Investigations Bureau (NSIB). This multi-jurisdictional drug task force (MJDTF) has a lieutenant and sergeant assigned to it from the Napa Police Department and the Napa County Sheriff's Office – with each of these agencies supplying either a sergeant or a lieutenant on a rotating basis. Police officers, deputy sheriffs, and a Deputy District Attorney are assigned to work on the task force. The officers and deputies are given a title of "agent" during their assignment to the task force so as to reinforce their role as a member of this highly specialized team.

### **Nevada County Sheriff's Office - \$97,603**

The Narcotics Task Force (NTF) plans to reduce illegal activities of targeted offenders through law enforcement, prosecution, and probation efforts by conducting special investigations. The NTF will work with other federal, state, and local drug enforcement agencies whenever possible, including prosecution and probation departments. The NTF works with, and maintains a close working relationship with, the members of the Sierra County Sheriff's Task Force. We have a reciprocal agreement with their operation and share personnel and information when needed. Among others, we also work closely with the local CDC Parole unit, IRS, and DEA to complete the investigations.

### **Orange County Sheriff's Department - \$528,547**

The task force will work closely with other law enforcement agencies to investigate and prosecute clandestine laboratory operators, precursor and essential chemical sources, and methamphetamine traffickers to achieve an overall reduction in the availability of methamphetamine, thereby improving the health, safety and welfare of all Orange County communities. The intended effect of the project will be to reduce the availability of methamphetamine in Orange County and improve public safety by eradicating hazardous methamphetamine labs.

### **Placer County Sheriff's Office - \$141,922**

The goal of this project is to utilize a multi-disciplinary task force concept and a multi-agency collaborative approach in order to reduce the impact of illicit drugs. This unified effort involving Placer County law enforcement agencies (i.e., local, state, and federal) will target narcotic offenders and their drug trafficking organizations (DTO's). This concept allows law enforcement to maximize available resources through a county-wide narcotic task force. The task force concept reduces the duplication of efforts by focusing on source areas and traffic patterns.

### **Plumas County Sheriff's Office - \$88,646**

The task force will work toward limiting the availability of illegal drugs to the users within the county, as well as affecting illegal drugs transported to other jurisdictions. Related information from any source will be thoroughly investigated. The intended purpose of these investigations will be to successfully arrest, prosecute, and appropriately supervise those in violation of state laws concerning illegal drugs, which will affect the availability of illegal drugs in the area. The primary investigations and arrests will predominantly be done by the Sheriff's Office. Some arrests may be made by the Probation Department and the California Highway Patrol. The Sheriff's Office will work with the District Attorney's Office for successful prosecution. The Probation Department will also work with the District Attorney's Office as well as supervising probationers from the project. All of the participating agencies will work in concert with each other to maximize the overall effort. The location of these investigations is within the jurisdiction of each of the involved agencies. Some investigations will also take us to other jurisdictions where we will assist the law enforcement agencies in those areas with investigations, as needed. The overall thrust of the project is to investigate, arrest, and prosecute over 200 illegal drug cases during the fiscal year.

### **Riverside County Sheriff's Department - \$589,216**

Riverside County is a significant part of the Inland Empire, an area identified by the Federal Drug Enforcement Agency (DEA) to be the methamphetamine capital of the world. Eradication of methamphetamine labs, as well as termination of all illegal drug activity is a high priority with local governments, who work diligently to make this area safe for their communities. The Anti-Drug Abuse Steering Committee has identified a priority objectives list which is as follows: targeting street- to mid-level drug trafficking in methamphetamine, heroin, cocaine, and marijuana; continuing highway interdiction of all narcotics; initiating school buy and other types of buy programs; increasing child welfare and protection; eradicating methamphetamine labs; removing criminal drug aliens; enhancing task forces with an Early Disposition Program; conducting probation searches from probation referrals; and increasing federal participation.

### **Sacramento County Sheriff's Department - \$541,531**

The Anti-Drug Abuse Enforcement Team (ADACAET) is a multi-agency task force comprised of (1) Sacramento County Sheriff's Deputy, (1) Senior Probation Officer, (1) HHS Social Worker w/Masters Degree (½ time) and (1) Deputy District Attorney Level 5 Criminal Prosecutor (1/3 time). The mandatory goal of the ADACAET is to target narcotic traffickers, manufacturers, and abusers who place children at-risk. ADACAET members will apply Drug Endangered Children (DEC) protocols in investigating crimes and protecting at risk children. ADACAET will also work with the Sacramento County Drug Endangered Children Program to train personnel, track DEC cases, and enhance the DEC protocol.

### **San Benito County Sheriff's Department - \$96,116**

The mission of the Unified Narcotic Enforcement Team (UNET) is to concentrate on all persons suspected of selling, manufacturing, cultivating, and transporting controlled substances within and through the UNET area of responsibility. Emphasis will be placed on the upper-, mid- and lower-level traffickers as identified through our proactive investigations from other law enforcement sources and relayed to us from concerned citizens.

### **San Bernardino County Sheriff's Department - \$592,180**

Since the 1990's methamphetamine use and manufacturing has remained the major drug problem in San Bernardino County. As this problem has spread law enforcement, probation, and prosecution have responded with resources to attack the problem. Our long range strategy is to reduce the use and manufacture of methamphetamine. Since San Bernardino County contributes significantly to the national use of methamphetamine, reduction in this county will have a national impact. The desired impact in our county is reduced environmental contamination from chemical dumps, reduced exposure of children to hazardous chemicals, and reduced manufacture and/or use of methamphetamine.

Narcotics Enforcement Operations are administered by a Lieutenant from the Sheriff's Narcotics Division. One (East Valley) Regional Street Enforcement Team (SET) within the project provides enforcement for street-level offenders in the San Bernardino Mountains, Valley area, West End to Yucaipa out to the west county line along the Interstate 10 corridor. One additional Regional Team (SET) provides enforcement for street-level offenders in the Hi-Desert area, Morongo Basin, and Victor Valley areas to the Colorado River. Sheriff's Department personnel work on these two teams. A third SET team (Ontario/Upland) is comprised of personnel from both Ontario and Upland.

### **San Diego County District Attorney's Office - \$714,613**

The task force will conduct special investigations using a multi-jurisdictional drug task force integrating federal/state/local drug enforcement agencies, prosecution, and probation departments into the primary suppliers of illegal drugs.

The JUDGE Unit has given San Diego law enforcement the opportunity to maintain a proactive stance against violent crime in local communities. It has also enabled local, state and federal entities to pool their resources together and effectively target known criminal offenders, address hot spots (high crime regions), and identify deep rooted criminal networks. Many local agencies have come to rely on the JUDGE Unit to assist them in more complex investigations or operations because traditional style patrol and investigative units are undermanned and inherently reactive in nature. Consequently, proactive units such as the JUDGE Unit have become essential to continued criminal apprehension and crime reduction. Additionally, the

shared intelligence among the different members results in quicker apprehension and earlier detection of county-wide crime sprees.

### **San Francisco City & County, Dept. of Children, Youth & Their Families - \$277,004**

The San Francisco Drug Elimination Team (DET) is a comprehensive and coordinated effort of strategic arrest, prosecution, and sanctioning. The Department of Children, Youth and Their Families (DCYF), San Francisco's law enforcement, criminal justice, and substance abuse treatment agencies work toward the reduction in use and sale of narcotics and violence in San Francisco.

Rotating Narcotic Enforcement Team (R-NET) operations include buy-walk operations, public housing narcotic enforcement, observed sales enforcement, search warrant preparation, and narcotics related parole and probation searches and surveillance. The strategy also entails coordinating law enforcement agencies in an effort against chronic violence, talking directly to those individuals identified as chronically criminally violent, and creating an environment in which a coordinated law enforcement team responds to their violence. An on-going goal is to create awareness for drug dealers and users that the police are committed to eliminating street drug trafficking and violence and that police have support from residents and businesses in these communities.

### **San Joaquin Sheriff's Office - \$336,644**

The San Joaquin County Task Force is a multi-jurisdictional task force composed of federal, state, and local law enforcement agencies within San Joaquin County. The jurisdiction for the task force is San Joaquin County and all of the incorporated cities within the county. The task force currently is the only local agency investigating medium to large scale drug trafficking organizations in San Joaquin County. The task force also participates in large scale investigations with federal agencies which often target drug trafficking organizations that operate within the region to include San Joaquin County and surrounding counties. The task force focus is to investigate mid- to upper-level narcotic distributors and manufacturers and to arrest and convict the subjects involved in those activities. The long-term strategy of the task force is to initiate and complete mid- to major-level narcotic investigations, which successfully lead to arrests and convictions. The task force is able to bring a collaborative effort and incorporate the use of law enforcement officers, prosecution, probation, and the Alcohol and Drug Program Administrator (ADPA) to create the most impact toward meeting our goals. The task force governing board, which is comprised of the Sheriff, Chiefs of Police, District Attorney, Chief Probation Officer, and Executives from state and federal agencies, believe that as a collaborative effort working together, the task force is the most efficient and productive narcotics unit within the county.

### **San Luis Obispo County Sheriff's Office - \$126,411**

The San Luis Obispo County ADA Enforcement Team is a multi-jurisdictional task force that integrates federal, state, and/or local drug enforcement agencies and prosecutors for the purpose of enhancing inter-agency coordination and intelligence, and facilitating multi-jurisdictional investigations. The ADA Enforcement Team is made up of personnel from the San Luis Obispo County Sheriff's Office, County Probation, District Attorney Investigators and local law enforcement.

### **San Mateo County Sheriff's Office - \$205,208**

The project title is the San Mateo County Narcotics Task Force (SMCNTF). The SMCNTF has been in existence for over 27 years, and operates under the authority of the San Mateo County Chief's and Sheriff's Association. The SMCNTF provides narcotics enforcement and training to all local municipalities in San Mateo County under a Joint Powers Agreement.

### **Santa Barbara County Probation Department - \$159,223**

To effect positive change in drug abuse in Santa Barbara County and to continue to make a successful impact on the community, an effective multi-jurisdictional drug task force is essential. The primary mission of the local ADA project, SBRNET, is to effect the profit margin for the area's drug vendors, find their hidden assets, and reduce the drugs available on the streets to provide a safer environment overall.

### **Santa Clara County District Attorney's Office - \$407,109**

Santa Clara County's most important narcotic issue is the local sales, distribution, manufacturing, and consumption of methamphetamine. To impact the enormity of this problem, the county must focus on both the street-level and mid-to-high level narcotic offenders within the borders of Santa Clara County. Furthermore, Santa Clara County has experienced a proliferation of illegal store front marijuana sales operations. These illegal store front operations have attracted a variety of collateral criminal activity. The approach outlined in the Santa Clara County ADA Budget Grant Application is designed to deal with these concerns.

### **Santa Cruz County District Attorney's Office - \$152,323**

The proposed project will fund the command and prosecution components of a multi-disciplinary, multi-jurisdictional drug task force known as the Santa Cruz County Anti-Crime Task Force ("SCCACT") in the County of Santa Cruz. SCCACT includes operational participation from the County Sheriff, District Attorney's Office, Probation Department, local municipal police departments, California Department of Correction and Rehabilitation - Parole, California Highway Patrol, and the U.S. Drug Enforcement Administration. Activities include the investigation, arrest, prosecution, and intensive probation supervision of targeted offenders involved in the distribution and manufacture of controlled substances such as heroin, cocaine, and methamphetamine.

### **Shasta County Sheriff's Department - \$129,755**

The Shasta Interagency Narcotic Task Force (SINTF) plans to reduce the illegal activities of targeted offenders through law enforcement, prosecution, and probation efforts by conducting special investigations. SINTF will work with other federal, state, and local drug enforcement agencies whenever possible, including the District Attorney's Office and county probation department.

### **Sierra County Sheriff's Office - \$85,514**

Sierra County has a permanent population of only 3,500, which is widely scattered in small mountainous communities throughout its rural 980 square mile county. Sierra County has a summer influx of 10,000 or more tourists, campers, and seasonal loggers and miners on any given day. The local drugs of choice are marijuana, illegally diverted prescription medication, and methamphetamine. Sierra County has seen an explosion of growth in the illegal cultivation of marijuana, including large scale drug trafficking organizations, and medical marijuana being illegally cultivated and diverted for non medical use. The Sierra County Joint Narcotic's Task Force will utilize grant funding to the pay salaries, rent aircraft, and purchase needed supplies.

### **Siskiyou County Sheriff's Department - \$92,045**

The Task Force has formed a nucleus of a multi-agency collaborative effort that attacks narcotic offenses being committed in Siskiyou County. Methamphetamine has become Siskiyou County's major problem and appears to be the drug of choice of northern California and southern Oregon. During the 11/12FY, the Task Force investigated 158 cases, resulting in 90 arrests. In 11/12, over 13 kilograms of methamphetamine were seized, over 700 doses of prescription drugs, 475 pounds of marijuana, and .2 kilograms of tar heroin. These seizures, plus other illegal drugs, resulted in almost \$10 million dollars worth of illegal drugs from our streets. The Task Force will also continue to provide educational outreach throughout the County

### **Solano County Sheriff - \$202,692**

The Multi-Jurisdictional Task Force special enforcement operations will combat street level, mid-level and upper level drug dealers, manufacturers, and distributors through informant buys, undercover operations, probation searches, and search warrants. The cases will be vertically prosecuted through sentencing. The Probation Department will identify and intensively supervise those defendants for which they have responsibility and will also work with the law enforcement component to identify high risk defendants under their supervision.

### **Sonoma County Sheriff's Office - \$157,176**

The County of Sonoma's Anti-Drug Abuse (ADA) Project helps to alleviate the County's narcotics problem by increasing the resources devoted to the narcotics enforcement activities and allowing for interagency collaboration. These resources result in increased investigative intelligence, the disruption of more illegal activities, and the apprehension and ultimately conviction of more offenders. Resources include personnel for enhanced criminal justice efforts, essential training, and investigative tools. The Project improves the ability to collaborate multijurisdictional criminal justice efforts to implement the objectives and achieve the desired outcomes.

The Project will support ADA objectives by increasing the following activities: (1) Conduct criminal investigations with the objective of reducing illegal narcotic activities; (2) Arrest and ultimately convict offenders of illegal narcotic activities; and (3) Seize illegal narcotics, weapons, and assets related to illegal narcotic activities.

### **South Lake Tahoe Police Department - \$110,229**

The South Lake/El Dorado Narcotic Enforcement Team (SLEDNET) set a goal to investigate suspects involved in illegal activity throughout neighborhoods where complaints were significant. SLEDNET agents accomplished the goal by successfully investigating narcotic

violators in accordance with its mission statement, which reads: "It is the mission of the South Lake/El Dorado Narcotic Enforcement Team to provide vigorous narcotic enforcement of state and federal laws within the community of South Lake Tahoe, and the rural areas within El Dorado County. The Narcotic Enforcement Team will be dedicated to assisting local agencies and identifying, arresting and prosecuting narcotic offenders in order to make the communities safe and free from the debilitating effects of drug abuse, thereby increasing public safety."

#### **Stanislaus - Modesto Police Department - \$251,372**

The Stanislaus Drug Enforcement Agency (SDEA) is a multi-jurisdictional task force integrating federal, state, and local law enforcement agencies, prosecutors, probation, and Stanislaus County Alcohol and Drug Education and Prevention Programs. SDEA combines the elements of drug education with drug enforcement as a proactive approach in our community.

#### **Sutter County District Attorney's Office - \$100,142**

Our Multi-jurisdictional task force is called Narcotics Enforcement Team 5 (NET 5) and is targeting mid-level/street level drug offenders. Yuba & Sutter County Sheriff departments, the two county District Attorney's and Probation departments, Yuba City Police, and various other law enforcement agencies participate. The grant only partially funds the salary of our dedicated full time Sheriff, Probation officer and Deputy District Attorney.

#### **Tehama County Sheriff's Office - \$97,436**

The Tehama Interagency Drug Enforcement (TIDE) Task Force, integrating federal/state/local drug enforcement agencies, prosecution, and probation departments, will reduce illegal activities. Although TIDE's initial focus is on street level, mid-level and large scale drug investigations, TIDE will work together to conduct proactive gang enforcement and assist agencies with gang investigations, as requested. TIDE will also continue to work together with stakeholders to reduce the supply of narcotics, and provide education programs to make a safer community in Tehama County.

#### **Trinity County District Attorney's Office - \$86,622**

The focus of this program is the support of multi-jurisdictional drug task forces to combat street to mid-level drug sales, manufacturing, and distribution through integration of federal, state, local law enforcement agencies and prosecutors to enhance interagency coordination and intelligence, and facilitate multi-agency investigations. The program involves law enforcement agencies with different jurisdictional responsibilities entering into an operational agreement to work together as a team to enforce drug laws. The Task Force includes the integration of a prosecutor to support the Task Force with prosecution efforts.

#### **Tulare County Sheriff's Department - \$211,963**

The main thrust for I-NET is to locate and eliminate mid-level illegal drug dealing. These drug traffickers move large amounts of illegal drugs in and out of the County, as well as within the cities in the County, and make drugs available to local youth. I-NET's mission is to identify, arrest, and eliminate drug trafficking organizations and individuals who control local drug operations.

### **Tuolumne County Sheriff's Office - \$94,248**

The project will continue the established county-based task force called the Tuolumne Narcotics Teams (TNT). TNT is a cooperative, collaborative, multi-disciplinary task force comprised of law enforcement, prosecution, and probation components. TNT is committed to investigating, arresting, and aiding in the prosecution of drug offenders within Tuolumne County and surrounding areas, where a nexus of criminal conduct can be established. TNT works closely with a multitude of agencies to include, but not limited to DEA, California State Parole, Child Welfare Services, District Attorney, Sonora Police Department, Bureau of Land Management, and the U.S. Forest Service.

### **Ventura County Sheriff's Office - \$193,667**

The goal of this project is to continue using a multi-agency collaborative approach to reduce the impact of illicit drugs within Ventura County. This unified effort, involving Ventura County law enforcement agencies (i.e., local, state, and federal), target major narcotic offenders and their drug trafficking organizations (DTO's). This concept allows law enforcement to maximize available resources through a countywide narcotic task force. The task force concept reduces the duplication of efforts by focusing on source areas and traffic patterns.

### **Yolo County District Attorney's Office - \$124,533**

The Yolo Narcotic Enforcement Team (YONET) will work in conjunction with the participating agencies to effectively enforce the controlled substance laws of the State of California as well as applicable federal laws related to the trafficking of controlled substances. YONET will target investigations toward the apprehension of street level dealers.

### **Yuba County Probation Department - \$97,995**

The Yuba County Drug Impact Program (YDIP) is an ongoing multi-agency drug interdiction program that places significant emphasis on curbing all illegal drug activity, especially as it relates to methamphetamine and its production. Monies to be used will partially fund positions for a Senior Deputy Probation Officer, a Deputy Sheriff III, a Deputy District Attorney III, and drug testing. This task force will enhance interagency coordination, intelligence, and investigations between Yuba County law enforcement, prosecution, and probation agencies.
