

**Out of Compliance Departments**

Eleven agencies were found Out of Compliance. They are listed below and a summary of the compliance issues for each department is included.

**Glenn County Probation Department – First Year Out of Compliance**

28 eligible corrections staff declared in the Annual Training Plan  
2108 minimum required hours declared in the Annual Training Plan  
2 staff failed to meet core training requirement (did not complete within one year)

**Humboldt County Sheriff’s Office – First Year Out of Compliance**

116 eligible corrections staff declared in the Annual Training Plan  
5,696 minimum required hours declared in the Annual Training Plan  
2 staff failed to meet core training requirement (did not complete within one year)

**Inyo County Sheriff’s Office – First Year Out of Compliance**

26 eligible corrections staff declared in the Annual Training Plan  
1,040 minimum required hours declared in the Annual Training Plan  
1 staff failed to meet core training requirement (did not complete within one year)

**Lassen County Sheriff’s Office – First Year Out of Compliance**

26 eligible corrections staff declared in the Annual Training Plan  
944 minimum required hours declared in the Annual Training Plan  
3 staff failed to meet core training requirement (did not complete within one year)

**Lompoc Police Department – First Year Out of Compliance**

11 staff failed to meet annual training requirement (short 160 hours)
