

Youth Reinvestment Grant Notice of Intent to Apply

City and county applicants interested in applying for the Youth Reinvestment Grant (YRG) are asked, but not required, to submit a **non-binding** Notice of Intent to apply. Failure to submit a Notice of Intent is not grounds for disqualification. Further, prospective city and county applicants that submit a Notice of Intent and decide later not to apply will not be penalized.

Listed below are the city and county applicants who have submitted a non-binding Notice of Intent to apply for YRG funds. In cases where an applicant has provided information about a Lead Public Agency, this information is also included. Note that applicant entities may opt to serve as the Lead Public Agency.
