California Gang Reduction Intervention and Prevention (CalGRIP) Grant Program 2015-2017 Completed Grant Cycle Overview

Summary

This information item provides summary information to the Board following the conclusion of the CalGRIP 2015-2017 grant program. Attachment 1 provides an overview of each of the funded grant programs. The Local Evaluation Report submitted by each grantee can be found on the BSCC website here. Grantees reported varying measures of success, from Los Angeles, where 98 percent of participants remained enrolled in school, to Fresno, which saw a 41 percent decrease in felony arrests in the targeted areas (though gang-related homicides increased) and Pico Rivera, which saw a 72 percent decrease in the number of guns found on school property and a 34 percent reduction in suspensions.

Background

CalGRIP was a state-funded grant designed to reduce gang violence through prevention, intervention and suppression strategies. Eligibility for the grant was limited to California cities, with preference given to cities that incorporated regional approaches to anti-gang activities.

From 2008 to 2016, the Budget Act annually appropriated \$9.215 million from the State Restitution Fund for CalGRIP awards. The Budget Act provided that the City of Los Angeles received \$1 million of that amount, leaving the rest to be competitively allocated by the BSCC. The Budget Act further required that cities establish a coordinating and advisory council to prioritize the use of funds, provide a dollar-for-dollar match and distribute at least 20 percent of their award to one or more community-based organizations pursuant to the city's application. The Board required that all grantees submit a Local Evaluation Report at the conclusion of the grant cycle.

The CalGRIP grant operated on a three-year calendar year cycle. The last grant cycle began on January 1, 2015 and ended on December 31, 2017.
