| Progress toward stated goal | In April 2022, the Sheriff's Office and MedMark executed an MOU which allowed for the delivery of Methadone for individuals who were incarcerated and taking Methadone. Methadone delivery and administration to jail inmates began in April 2022. In September of 2022, Wellpath began a "soft launch" of the Withdrawal Protocol which includes the use of Buprenorphine to assist those with Opiate Use Disorder who meet criteria to withdraw from the use of opiates. |

| Progress Toward Stated Goal | The Sheriff's Office has been allowed to utilize the Rourk Vocational Training Center to provide vocational training to justice involved individuals inclusive of both inmates and those under probation supervision. In May 2022, the Sheriff's Office and the Department signed an MOU indicating the Sheriff's Office would provide facilities, Correctional Staff and Vocational contractors, and the Department would screen and refer clients, provide staffing to monitor classes, and arrange transportation. In June 2022, the first class of probation clients participated in the Laborer's Union Pre-apprenticeship Program which ran for one month. Additional classes included: another Laborer's Union Class in August 2022 and a Welding Class offered by Solano College from October to early December 2022. Vocational classes for inmates included: Forklift Training in July 2022; Scissor Lift Training in September 2022; Warehousing Training in September 2022 and a Laborer's Union Class in December 2022. |

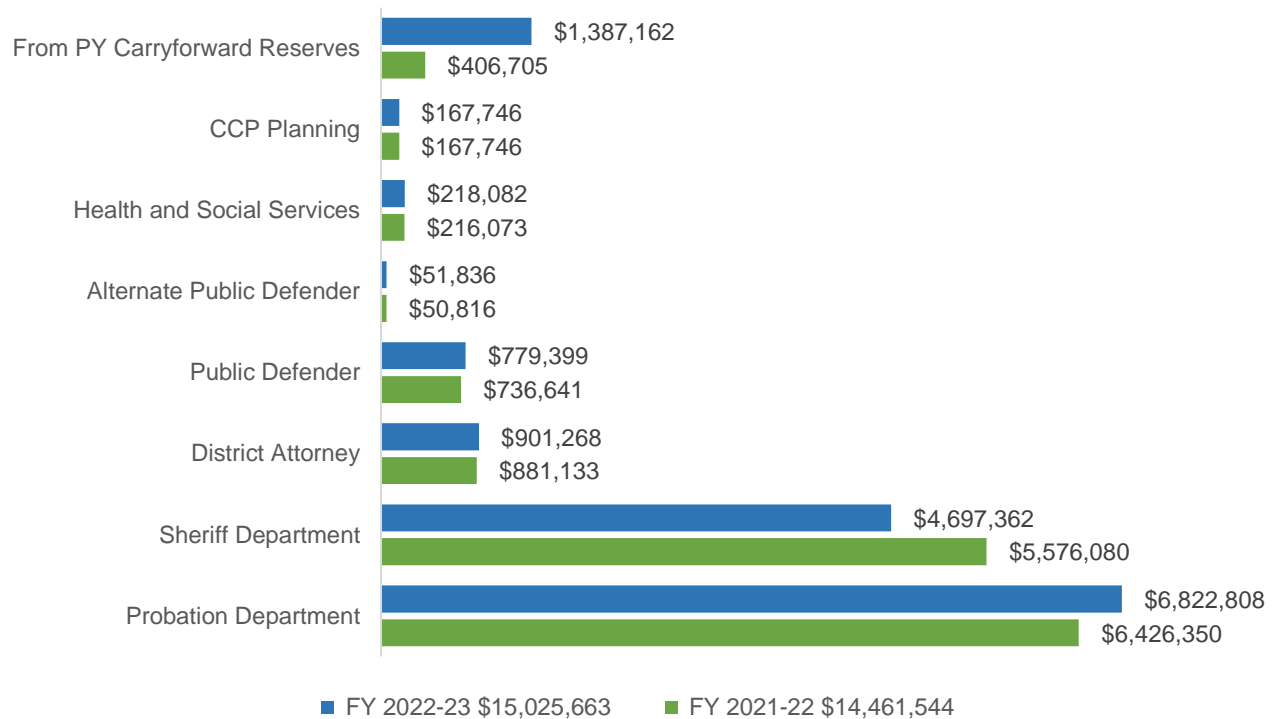

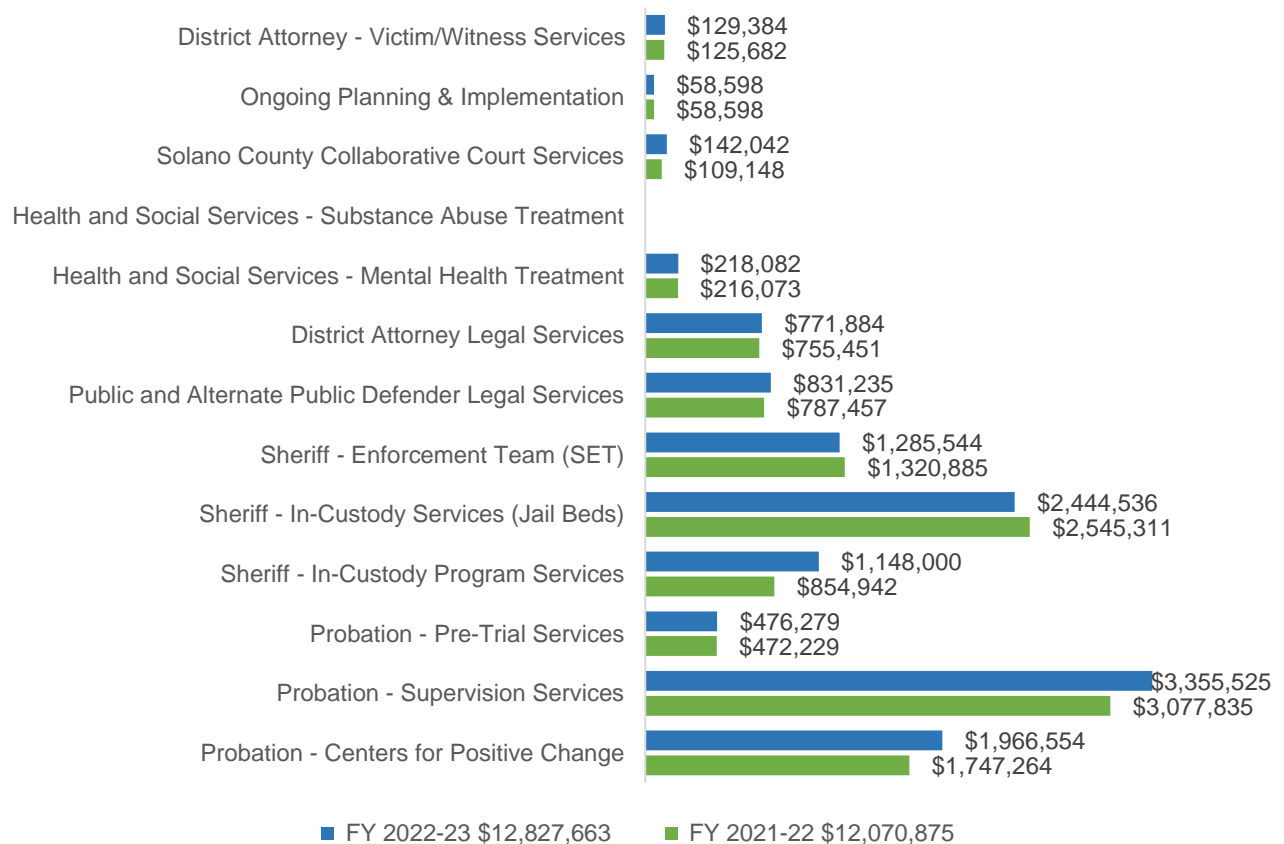

## FY 2021-2022 and FY 2022-23 Allocation Comparison

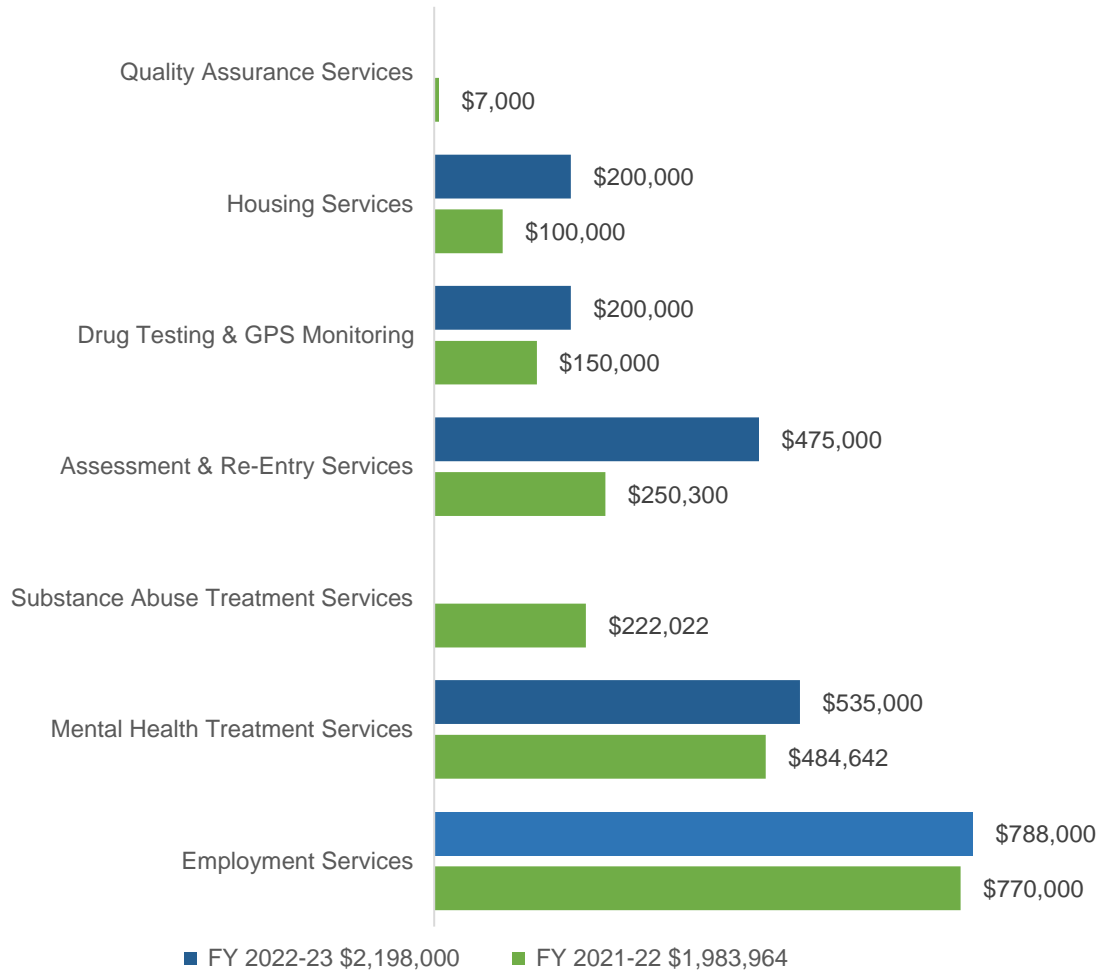
### FY 21-22 and 22-23 Allocations

The Men's Empowerment Group (MEG) is designed to be a client centered and culturally relevant intervention facilitated by Black men for Black men experiencing common barriers in their lives. The goal is to provide the group with a unique experience, while addressing specific needs, and creating new life goals. Core topics and concepts covered during the 10- week class include Y-Chromosome Adam, PTSD and PTSS/Generational Trauma, War on Drugs, Privilege, Goals, 3 types of business structures, Starting a business in 15 minutes, How to write business plan, Mental health stigma in the Black Community, Black Wallstreet in Tulsa 1921, Anxiety and depression, The Buy Black Movement, Home ownership, Gentrification, Redlining, Repair a Broken Relationship, Financial Literacy, ,Interviewing, Networking, Raising black children, Survival mode, Maslow's hierarchy of needs, and Responding vs Reacting.

Utilizing a trauma-informed curriculum, Mental Health Clinician, DeShannon Williamson, LCSW, also goes far back in his facilitation from discussing DNA, pre-slavery, slavery, Jim Crow, to the present as far as showing the generational trauma and how it has impacted black men (people) presently. He also discusses awareness of the impact of systemic racism (redlining) and how addressing trauma (depression, stress, and anxiety) and financial disenfranchisement (understanding money, how to buy a home, how to own your own business and advocating for yourself) can help end this cycle. He touches on relationships and fatherhood, which for black men is such an essential topic to delve into.

Participants of this group have responded positively to the group and have shared some of the following feedback.

"Now I'm starting to understand why I do what I do." I reflected, and he said, "I have watched so many men where I'm from act a certain way, and before I knew it, I was doing the same thing. I was hustling by the time I was 14."

"I liked the information I received in this MEG class. Information I didn't know existed such as PTSD, Black Tulsa 1921, and (how) PTSD is passed on from generation to generation. Now I understand my fight with addiction, mental health, stress, and basically coping with life."
