SUBJECT: Local Detention Facilities Inspection Update: **Requesting Approval**

Summary

This report is a regular update on the local detention facility inspections completed in the 2025/2026 Biennial Inspection Cycle, a summary of current outstanding items of noncompliance for targeted inspections, and requests the Board to ratify three Corrective Action Plans (CAP) as required by Welfare and Institutions Code section 209 (d) (2) (B).

Background

The 2025/2026 inspection cycle began on January 1, 2025, and will conclude on December 31, 2026. BSCC staff continue to track the status of corrective action plans for items of noncompliance identified during inspections. All county jails and juvenile detention facilities will receive a comprehensive inspection in 2025; each county jail and juvenile detention facility will also receive a targeted inspection in 2026. Unannounced and follow-up inspections will continue throughout the inspection cycle, and Type I Jails, Temporary Holding Facilities, and Court Holding Facilities will also receive comprehensive inspections.

Assembly Bill (AB) 134 (Ch . 10, Stats. 2025) codified the delegation of authority for the Executive Director of the BSCC or the Deputy Director of the Facilities Standards and Operations Division to approve or deny CAPs submitted pursuant to Welfare and Institutions Code section 209 (d) (1). With this delegation, Welfare and Institutions Code section 209 (d)(2)(B) requires the BSCC Board to ratify or overrule the deleguee's approval or disapproval of the CAP at its next regularly scheduled meeting. The Board's decision to ratify or overrule does not affect the effective date of the CAP timeline.
