The final Corrective Action Plan (CAP) for the Los Angeles County Probation Department Juvenile Facility, Camp Afflerbaugh was received on August 1, 2025, and is approved effective August 5, 2025.

In an email received Friday, August 1, 2025, from Aaron Broom, Executive Manager, it was stated the agency has completed all CAP activities effective July 28, 2025 and is in compliance with the related section of Title 15, previously identified as non-compliant.

In response to the Board of State and Community Corrections (BSCC) inspection conducted on Camp Clinton B. Afflerbaugh during the days of June 9 – 11, 2025, Los Angeles County Probation Department is submitting the following Corrective Action Plan (CAP) as it pertains to BSCC Title 15 – 1371 Programs, Recreation and Exercise.

Summary:

Per the Initial Inspection Report (IIR), the inspection found Camp Afflerbaugh failed to properly document as required under Title 15 – 1371 and RTSB-1300 Section 1306 Programs, Recreation and Exercise. The IIR describes the finding as "Agency documentation of programs, recreation and exercise is inconsistent and does not accurately reflect the actual provision of required activities. While interviews with youth confirmed the opportunity for the required 1 hour minimum for programs, recreation and exercise exists, the documentation does not reflect this in a manner which could be verified and must be corrected to ensure full compliance. To exhibit proof of practice, the Department will ensure that all required programming, exercise, and recreation are accurately recorded and documented."

As a result of the finding, a review of the documentation process was conducted. Changes were made to ensure all staff are aware of updates, that all staff involved are well trained, and to certify that the facility has a robust quality assurance process. The process would identify incomplete, missing, or incorrect documentation., Staff responsible for the deficiencies will receive the appropriate training and corrective measures, including progressive discipline if warranted. In addition, a revised Programming Calendar format has been created to ensure youth do not have to choose between Programming and Exercise or between Programming and Recreation. Additionally, the revised calendar ensures that all youth shall receive the required minimum hours of Programming, Exercise, and Recreation. Updates to the facilities process are outlined below.

- Trained deputies are identified to complete the Title 15 Programming, Recreation, and Exercise Log.
- A new designated Title 15 Programming, Exercise, And Recreation Log Coordinator (PEARL Coordinator) has been created to review 100% of all Title 15 Programming, Recreation, and Exercise Log.
- A new Title 15 Programming, Exercise, And Recreation Log Audit sheet has been created and shall be completed by the PEARL Coordinator and submitted to the CBA On-Duty Supervisor, with copies to the Facility BSCC coordinator, CBA Assistant Director, and Director.
- CBA's On-Duty (AD) shall ensure that identified discrepancies are addressed with required training, and appropriate corrective measures, including progressive discipline.
- A revised Programming Calendar format has been created to ensure youth are not having to choose between exercise and recreation or between exercise and programming.
