Ms. Molennor,

Thank you for providing the Initial Inspect Reports (IIRs) for the 2025-2026 Biennial Inspection Cycle for the Fresno County Probation Department Juvenile Hall (known as the Detention Facility), Camp (known as the Commitment Facility) and Secure Youth Treatment Facility (known as SYTF). We have reviewed the IIRs and items of non-compliance in preparation for the included CAP.

Following the three-day Comprehensive Biennial Inspection on August 28, 2025, a BSCC Exit Briefing was held. BSCC found that we were not in compliance with Title 15 Section 1313, County Inspection and Evaluation of Building and Grounds, for our Juvenile Hall, Camp and SYTF Facilities. Specifically, the facility has not had an inspection completed by the county building inspector or person designated by the Board of Supervisors to approve building safety since August 16, 2023.

Our Corrective Action Plan is attached for your review and outlines the specific issues/concerns related to the non-compliance findings and the department's response to bring the facilities into compliance with BSCC guidelines and standards. Our remediation plan includes an updated facility inspection, quality control and gap measure prevention strategies to avoid future lapses in inspection. We have worked on compliance and are pleased to report that we are in compliance as of September 10, 2025.
