The SOQ serves as documentation of each candidate's ability to present information clearly and concisely in writing. The SOQ must not exceed two (2) pages in length, in 12-point Arial font, with 1-inch margins. Responses must be no more than 1 page in length, size 12-point Arial font, and address the following questions. Grammar, spelling, and punctuation will also be factors in evaluating the SOQ. Resumes, letters, and other materials will not be considered as your response to the SOQ. Your SOQ must specifically address the following question to be considered for this position:

- Describe your experience in data mining, collating, analyzing, and interpreting data. This example must be related to an activity in your resume.
- Provide a specific example describing how you have developed reports, created dashboards, and/or delivered presentations of findings to management. This example must be related to a recent activity listed on your resume.

Scope of Position:

Under general direction of the Research Data Supervisor II (RD Sup II), the Research Data Analyst II (RDA II) is a member of the Research unit responsible for supporting the lead staff over the evaluation of criminal and juvenile justice grant and pilot programs, special research projects, and the collection and analysis of data from local community corrections agencies. The incumbent will be teamed on evaluation projects for grant-funded criminal justice related programs. The data collection, standardization, cleaning, and validation of data in support of the Board of State and Community Corrections grant programs are the core skillset areas of this position. This position requires data analytics software skills, detail and eye for accuracy,

This position works in conjunction with Research Data Specialists (RDSs). They will also work with Field Representatives from Corrections Planning and Grant Programs (CPGP), Facilities Standards and Operations (FSO), Standards and Training for Corrections (STC) and the County Facilities Construction (CFC) when gathering, validating, and cleaning data.

Duties and Responsibilities:

(Candidates must perform the following functions with or without reasonable accommodations.)

- Provide support to lead staff related to planning and conducting specialized research projects, complex studies, and data collection projects, including any associated statistical analyses, to address BSCC's data collection, data reporting, and research mandates and questions posed by various entities (e.g., management, legislative bodies). Prepare technical reports and support recommendations to management based on findings. Implement the dissemination and technical assistance on a wide variety of large-scale surveys, collect and subset data as required by lead staff. Use of SAS/SAS EG, SPSS, R, Tableau, Atlas Ti, and Excel may be required to accomplish these projects.
- In conjunction with lead staff and utilizing guidance and procedures from the Research Unit: design, develop, and document methodologies to collect and clean, standardize and validate, the data used to evaluate program-wide and project-specific outcome results for grant programs, pilot programs, or other projects. Provide technical assistance to local program data reporters regarding issues related to data submission, data collection, evaluation of outcomes, and support lead staff during preliminary and final local evaluation reports. Technical assistance may include some or all: preparing collection materials, preparing training materials, providing training, providing support and assistance with research design to RDSs, and assisting with tracking and organizing the identification, development, and coordination of resources (external or internal). This includes, defining necessary data elements, developing data dictionaries and procedures, and supporting collaborative efforts. Incumbent will review, interpret, and analyze data from grantee and program reports (progress, preliminary, and final) and provide interpretation to the research project team lead specialist and assigned field representative. May also assist in identification of points of comparison between programs and make recommendations to lead RDS for data correlation and/or contrast. Assists in preparation and draft of written materials/reports for the BSCC, state legislature, grantees, and stakeholders on the program-wide outcomes of grant fund investments. Assist in the presentation of data
- Participate in meetings, trainings, and steering committee, stakeholder, and staff orientations, trainings, and technical assistance meetings; provide assistance and back up during rater trainings.
