

***AB 900 County Jail Construction or Expansion
Proposal Summaries
March 18, 2008***

<i>County</i>	<i>State Funds Requested</i>
<i>Amador</i>	<i>\$22,712,000</i>
Construct a new Type II, 165-bed jail and related ancillary space in Martell, while eliminating 76 beds (net gain of 89 minimum, medium and maximum security beds).	
<i>Butte</i>	<i>\$30,000,000</i>
Add 203 beds and related ancillary space to the Butte County Jail in Oroville, while eliminating 99 beds. Additional work includes a new central control, classification, transportation and laundry; and remodeling of kitchen, booking and medical (net gain of 104 maximum and medium security beds).	
<i>Calaveras</i>	<i>\$26,387,591</i>
Construct a new Type II, 240-bed jail and related ancillary space in San Andreas, and eliminate 65 beds, of which 160 beds and related ancillary space are proposed to be part of the state bond project. There will be a net gain total of 175 beds, of which 95 maximum, medium and minimum security beds are for the state bond project (160 - 65 = 95).	
<i>El Dorado</i>	<i>\$20,000,000</i>
Add 128 beds and related ancillary space to the Placerville Jail in Placerville (net gain of 128 minimum security beds).	
<i>Kern</i>	<i>\$100,000,000</i>
Construct a new Type II, 790-bed jail and related ancillary space at the Lerdo jail complex in Bakersfield, to include an adjacent on-site visitor's center and property storage warehouse (net gain of 790 maximum and medium security beds and special use beds).	
<i>Kings</i>	<i>\$30,000,000</i>
Construct Phase II of the Kings County Jail in Hanford, adding 170 beds and related ancillary space (net gain of 170 maximum and medium security beds and special use beds).	
<i>Los Angeles</i>	<i>\$100,000,000</i>
Construct a new Type II, 1,152-bed jail and related ancillary space in Lancaster (net gain of 1,152 maximum security beds).	

Madera \$30,000,000

Add 144 beds and related ancillary space to the Madera County Jail in Madera (net gain of 144 maximum and medium security beds).

Merced \$27,846,040

Add 96 beds and related ancillary space at the John Latarocca Adult Correctional Center in El Nido (net gain of 96 medium security beds).

Monterey \$80,000,000

Add 448 beds and related ancillary space at the Monterey County Jail in Salinas. The project includes a new central control, program spaces, intake/release area, expanded support services space and renovations of other areas for a net gain of 448 maximum and medium security beds.

Orange \$100,000,000

Construct a new Type II, 1,536-bed jail and related ancillary space in Irvine (net gain of 1,536 medium and minimum security beds).

Placer \$9,389,606

Construct a new Type II, 360-bed jail and related ancillary space in Roseville, of which 220 beds and related ancillary space are proposed to be part of the state bond project. There will be a net gain of 220 maximum and medium security beds for the state bond project, and a net gain of 360 maximum and medium security beds for the County.

San Benito \$15,053,000

Add 60 beds and related ancillary space to the San Benito County Jail in Hollister, and also renovate and expand support spaces and program areas including central control, intake/release, laundry and visiting (net gain of 60 medium security beds).

San Bernardino \$100,000,000

Add 1,368 beds and related ancillary space to the Adelanto Detention Facility in Adelanto which includes an inmate services building with inmate processing, medical, video arraignment and kitchen storage areas (net gain of 1,368 maximum security beds).

San Diego \$100,000,000

Construct a new Type II, 1,270-bed womens' jail and related ancillary space in Santee, eliminating 428 beds, for a net gain of 842 maximum, medium and minimum security beds and special use beds.

San Joaquin **\$80,000,000**

Add 1,280 beds and related ancillary space to the John J. Zunino Detention Facility in French Camp. The project will also include a new video visitors center, central control, and administration and staff services space for a net gain of 1,280 maximum and medium security beds.

San Luis Obispo **\$25,125,630**

Construct a new Type II, 198-bed womens' jail and related ancillary space in San Luis Obispo, and construct a new medical and mental health programs center, while eliminating 43 beds for a net gain of 155 maximum, medium and minimum security beds and special use beds.

San Mateo **\$100,000,000**

Construct a new Type II, 652-bed jail and related ancillary space in Redwood City, eliminating 146 beds, for a net gain of 506 maximum, medium and minimum security beds and special use beds.

Santa Barbara **\$56,295,000**

Construct a new Type II, 304-bed jail and related ancillary space in Santa Maria (net gain of 304 maximum and medium security beds).

Shasta **\$24,999,187**

Construct a new Type II, 229-bed jail and related ancillary space in Redding (net gain of 229 medium security beds).

Stanislaus **\$39,790,500**

Add 420 beds and related ancillary space at the Public Safety Center in Modesto, of which 300 beds and related ancillary space are proposed to be part of the state bond project. There will be a net gain of 300 maximum and medium security beds and special use beds for the state bond project, and a net gain of 420 beds for the County.

Sutter **\$5,990,288**

Add 42 beds and related ancillary space to the Sutter County Jail in Yuba City. Convert female recreation yard to medical exam area, build a new female recreation yard, and renovate and expand the kitchen for a net gain of 42 maximum and medium security beds.

Tuolumne **\$30,000,000**

Construct a new Type II, 260-bed jail and related ancillary space in Sonora, eliminating 149 beds for a net gain of 111 maximum, medium and minimum security beds.

Yolo**\$30,000,000**

Add 157 beds and related ancillary space to the Monroe Center Main Jail in Woodland. Renovate and expand intake, booking, medical, mental health and support areas; and construct a new visitor's center, kitchen and laundry for a net gain of 157 maximum security beds and special use beds.
