

Proposition 47 Grant Program: Demographics and Recidivism Update

PURPOSE OF PRESENTATION

- ◆ For Cohort 1, provide the demographic information and recidivism data, which suggests a possible reduction in recidivism rates for program participants
- ◆ Provide demographic information and preliminary outcome data on Prop 47 Cohort II grantees' progress through September 30, 2021
- ◆ Introduce the Prop 47 Cohort II Statewide and Grantee Dashboards

PROPOSITION 47

- ◆ Reduce low-level, nonviolent, property and drug crimes from felonies to misdemeanors
- 65% of the net state savings are distributed to the Board of State and Community Corrections
- Programs and services designed to serve:
 - ◆ Individuals involved in the justice system
 - ◆ AND have a history of mental health or substance use disorder

PROPOSITION 47 COHORTS

◆ Cohort I

- ◆ June 16, 2017 – August 15, 2020
- ◆ 1 year no-cost extension to August 15, 2021
- ◆ Final local evaluation reports were due September 30, 2021

◆ Cohort II

- ◆ August 15, 2019 – December 31, 2022
- ◆ Similar RFP with minor modifications
- ◆ One modification included an enhanced data reporting procedures
 - ◆ Common data elements across grantees
 - ◆ De-identified participant level data

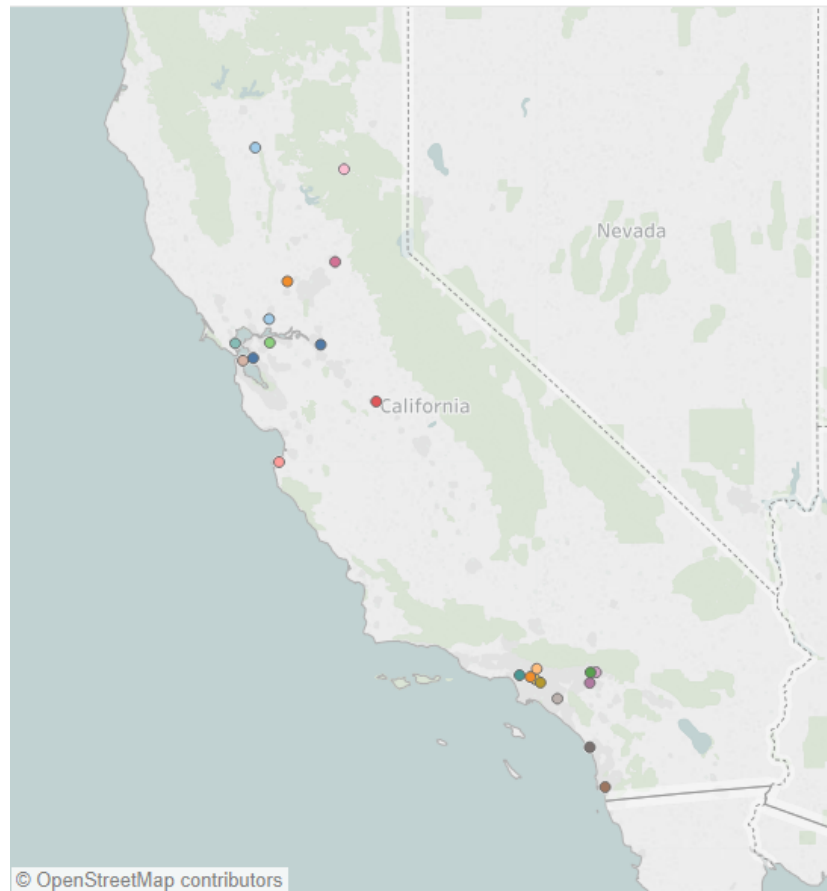

RECIDIVISM DEFINITION

Conviction of a new felony or misdemeanor committed within 3 years of release from custody or committed within 3 years of placement on supervision for a previous criminal conviction (AB 1056).

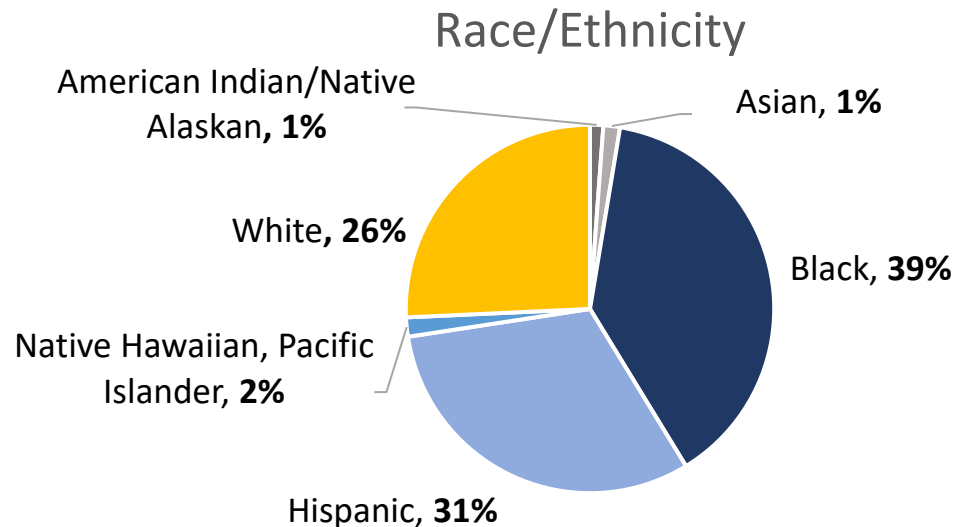

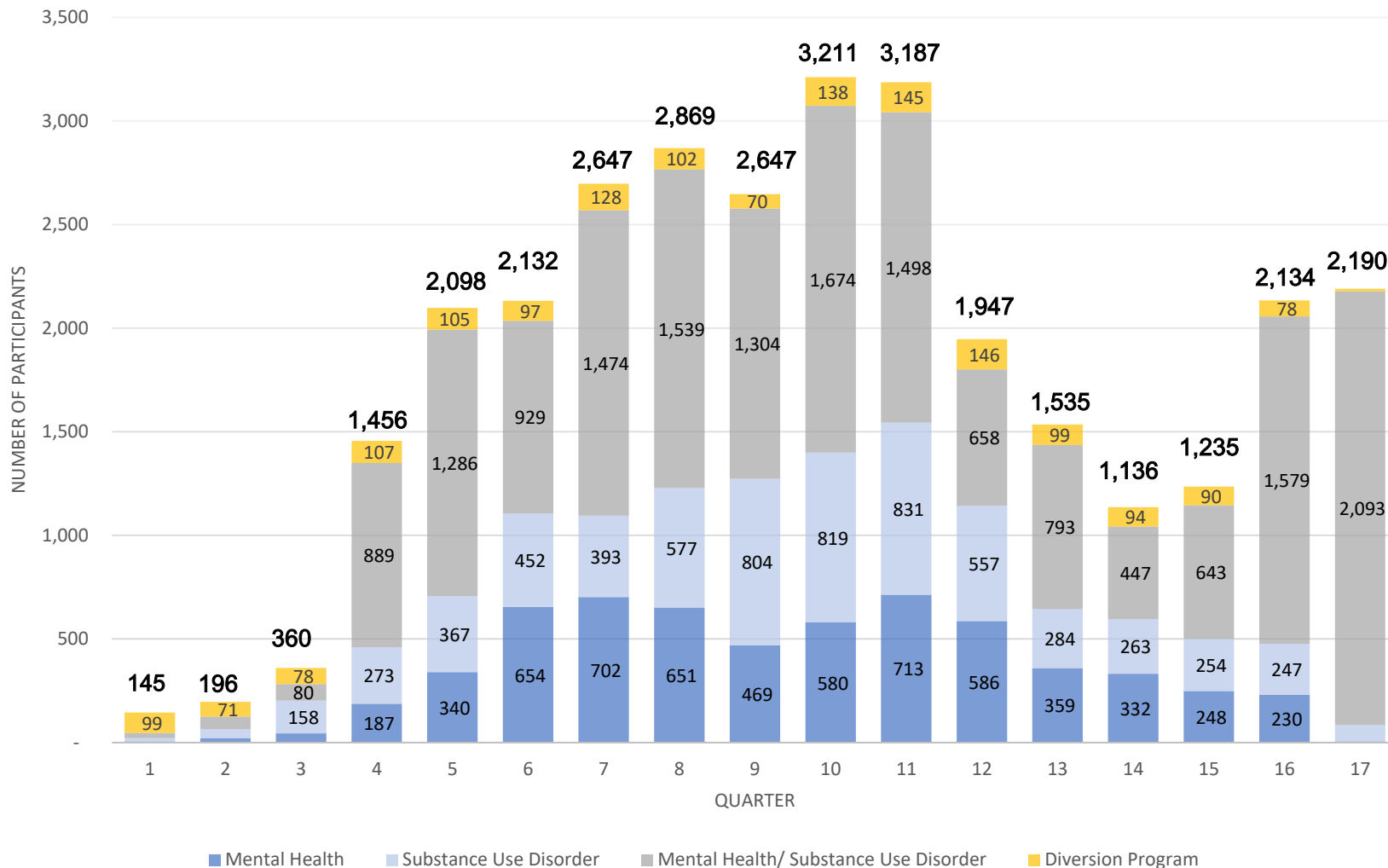

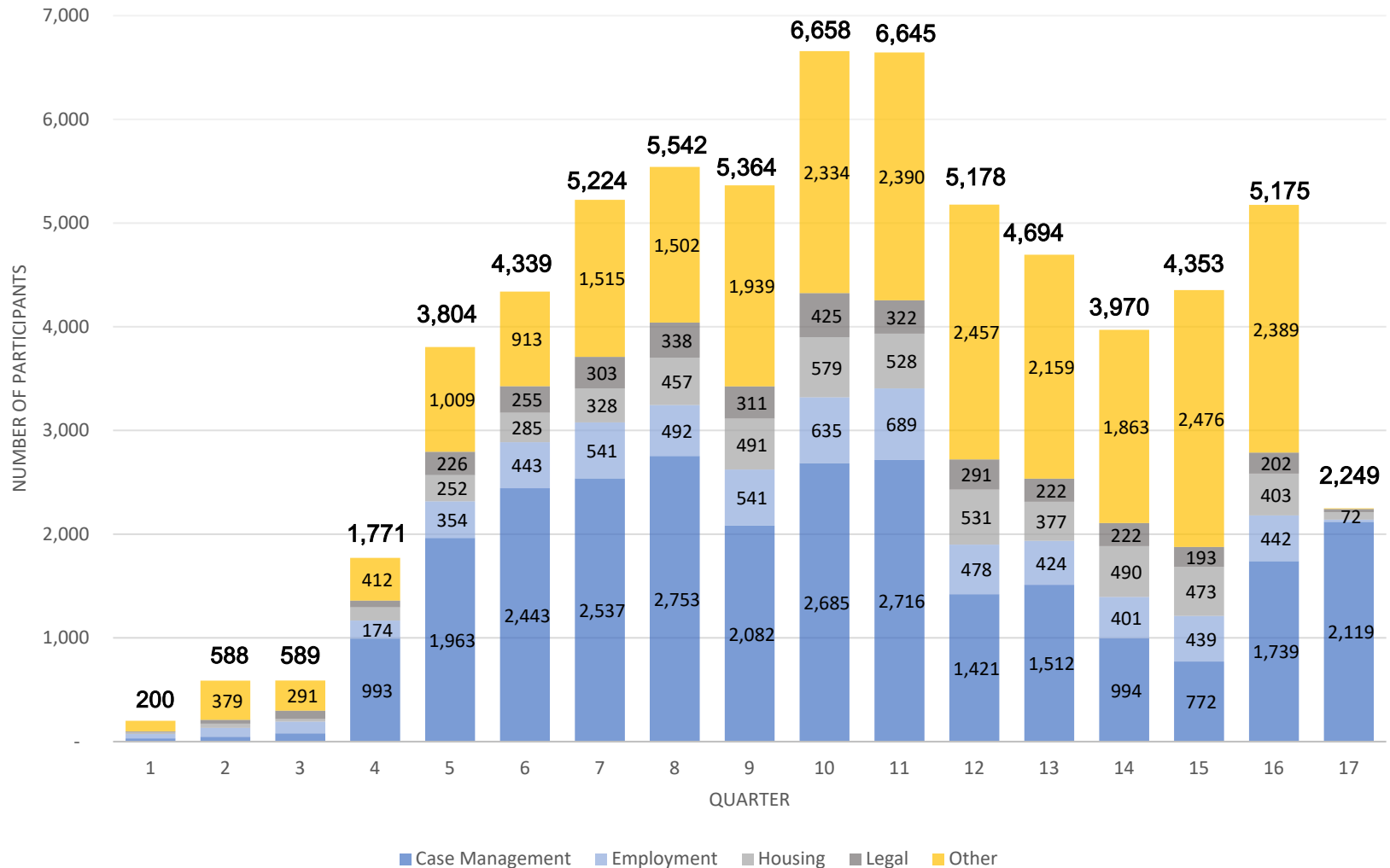
COHORT I REQUIRED SERVICES

NUMBER OF PARTICIPANTS WHO RECEIVED THE SERVICE DURING THE QUARTER



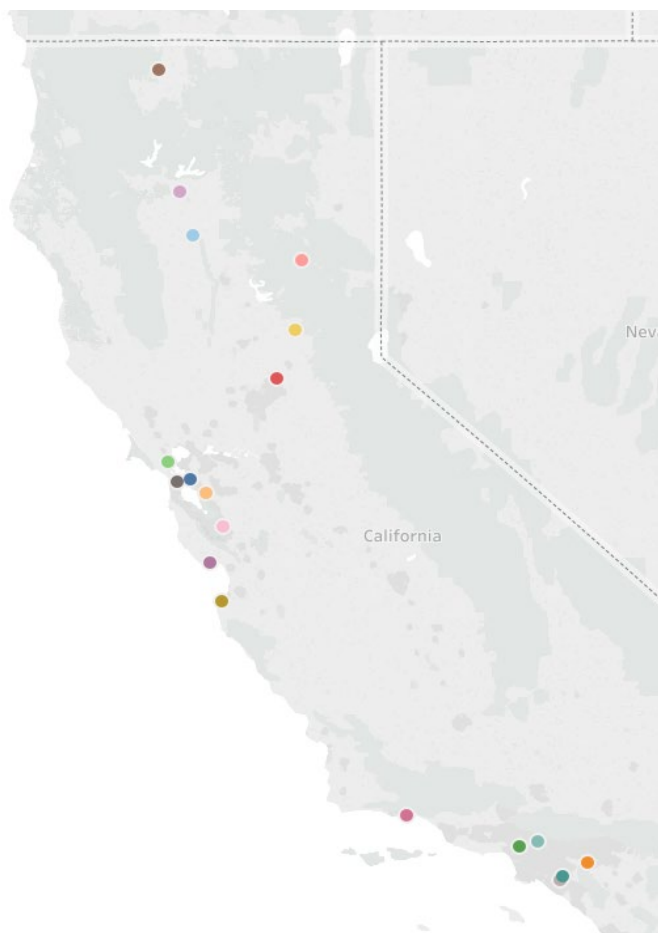

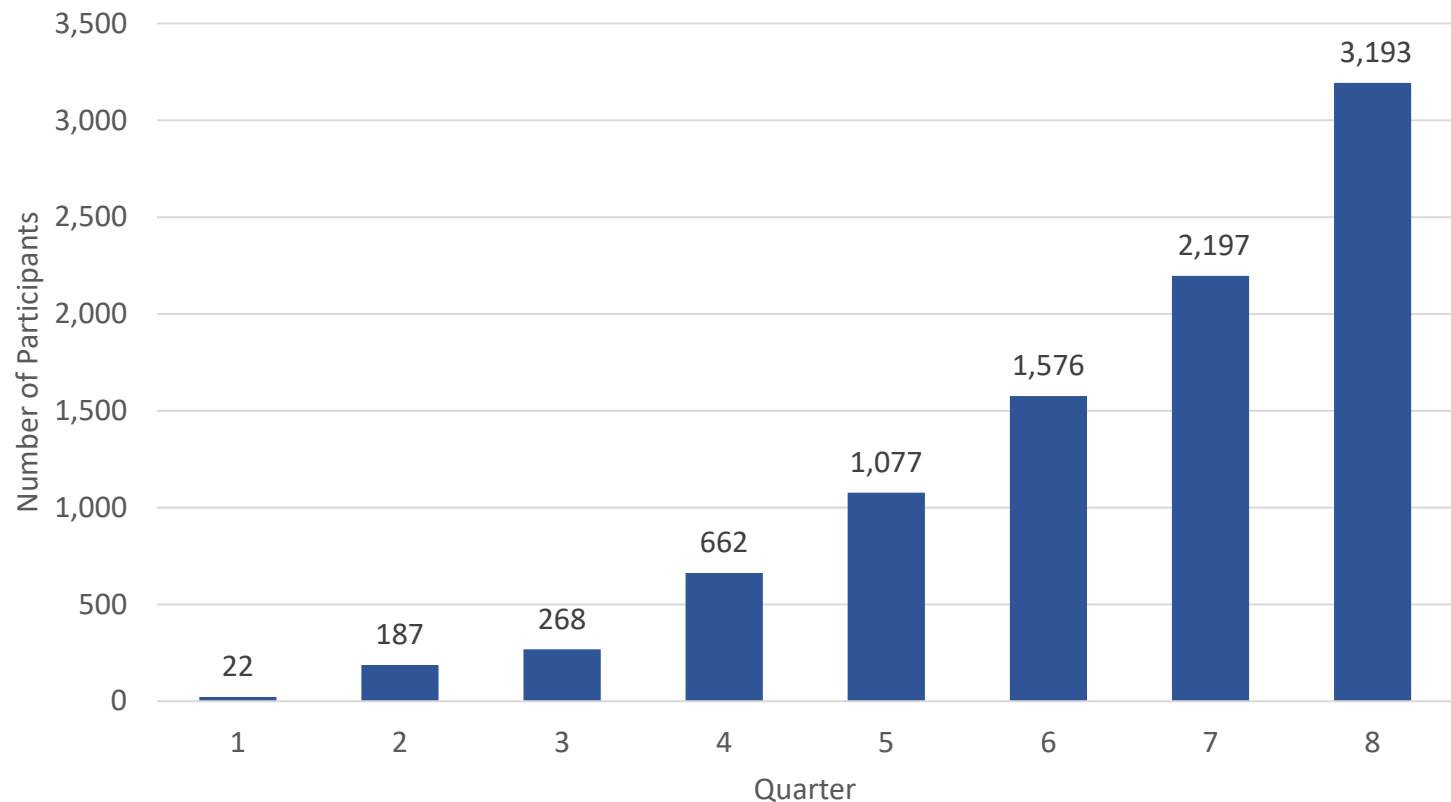

5,304 unduplicated participants received services through Prop 47 Cohort 2 funding during the first two years



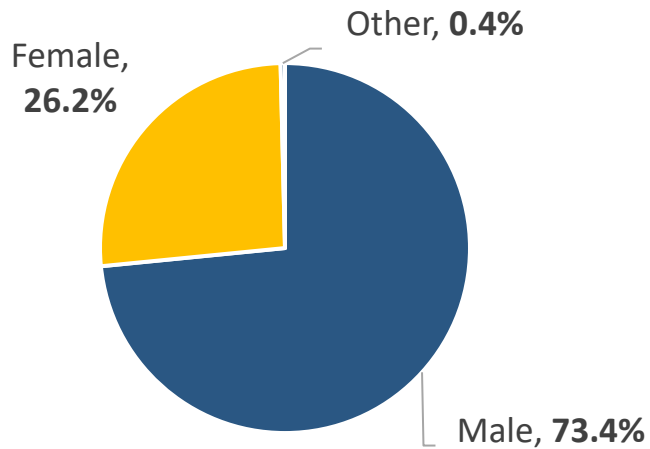
COHORT II PARTICIPATION STATUS



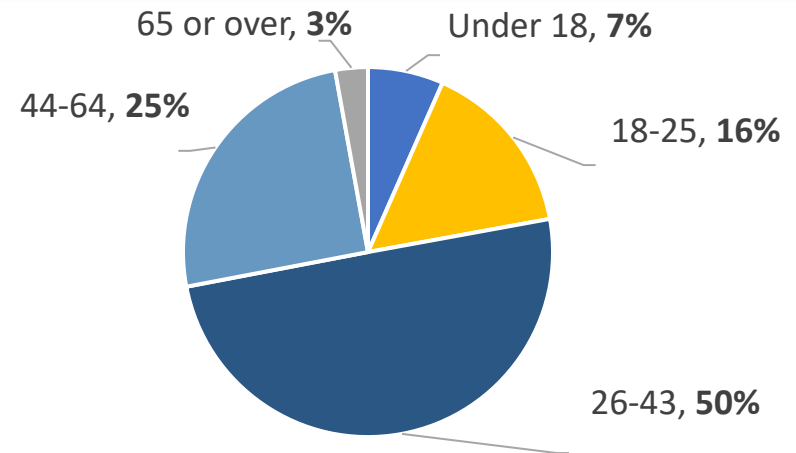

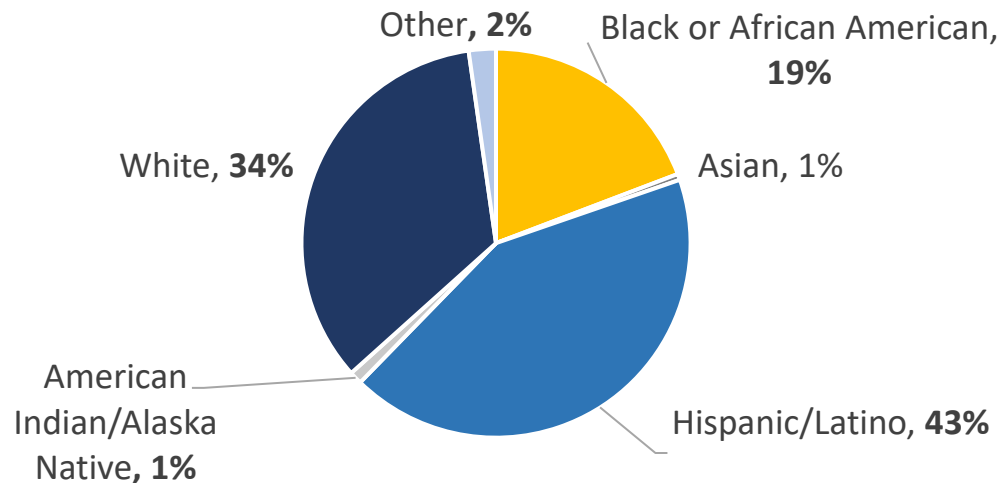
Gender



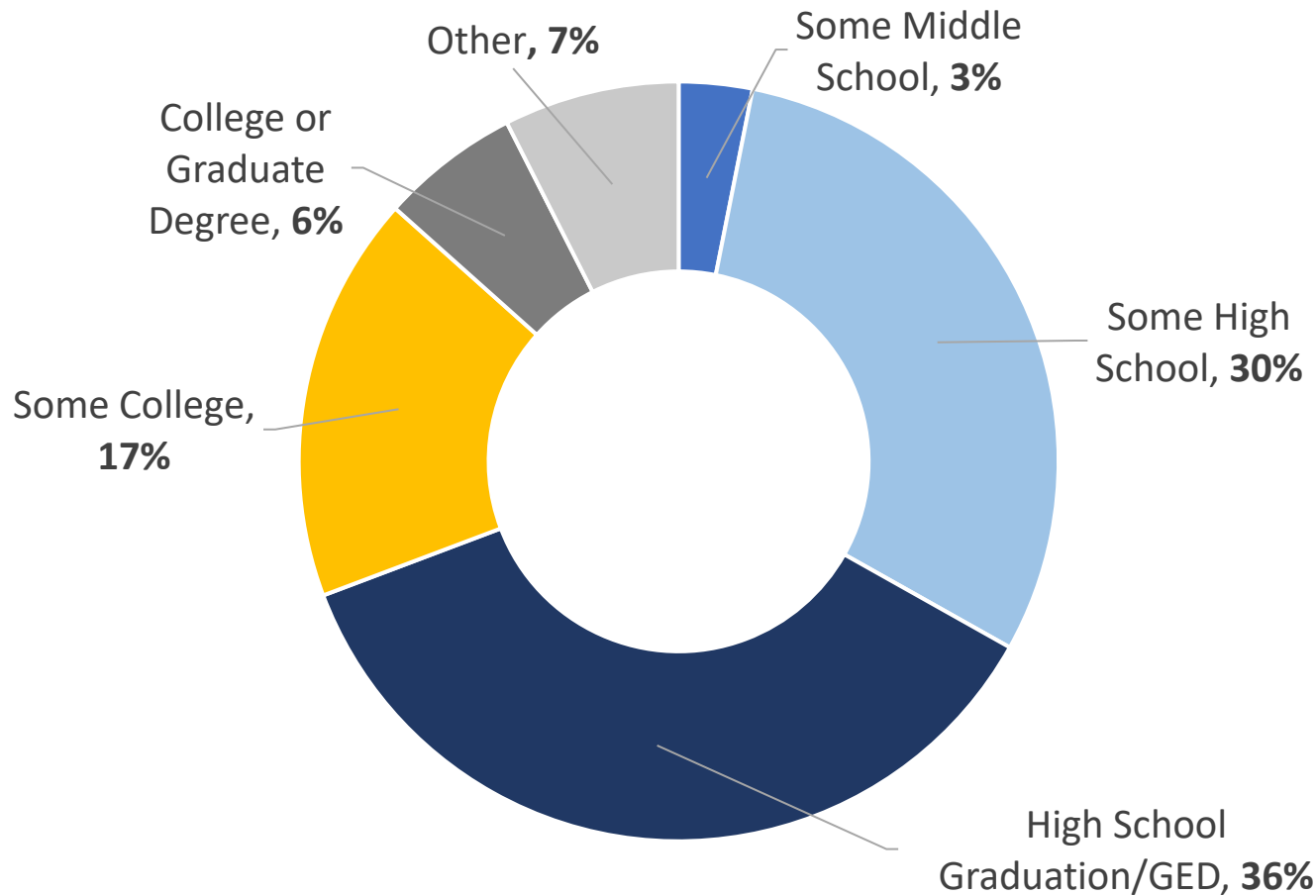
Age



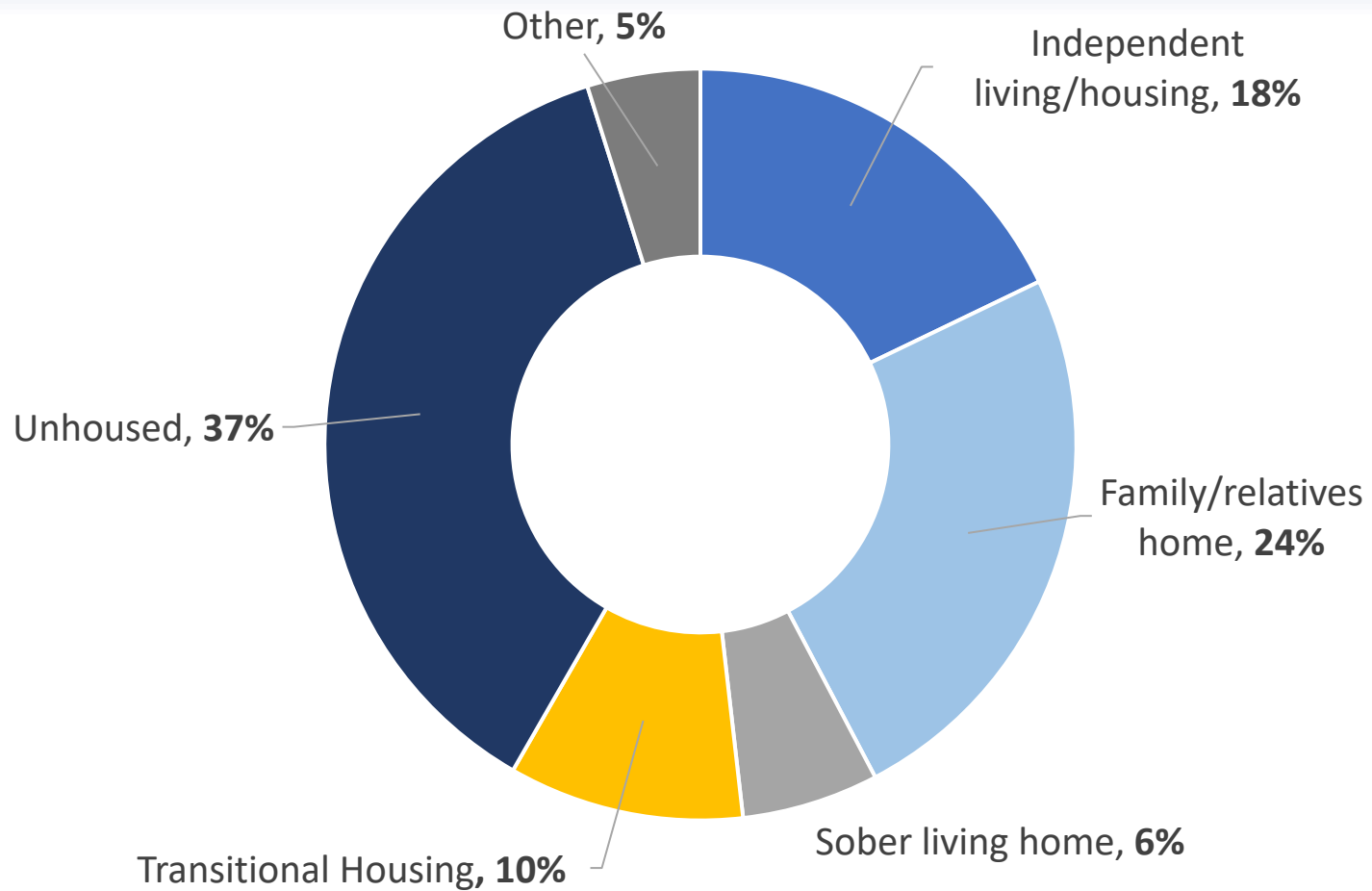
Race/Ethnicity



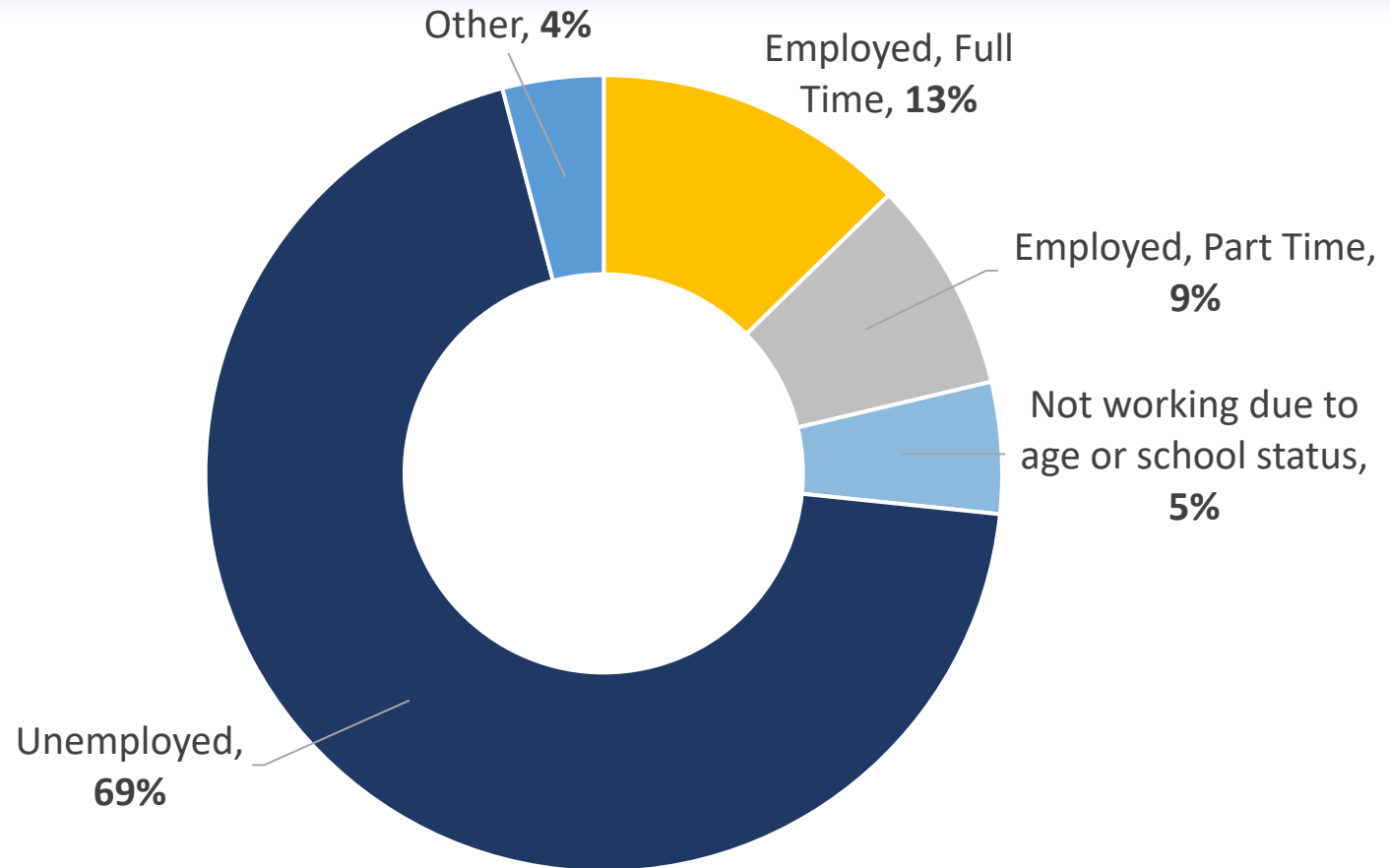
COHORT II LEVEL OF EDUCATION AT ENROLLMENT



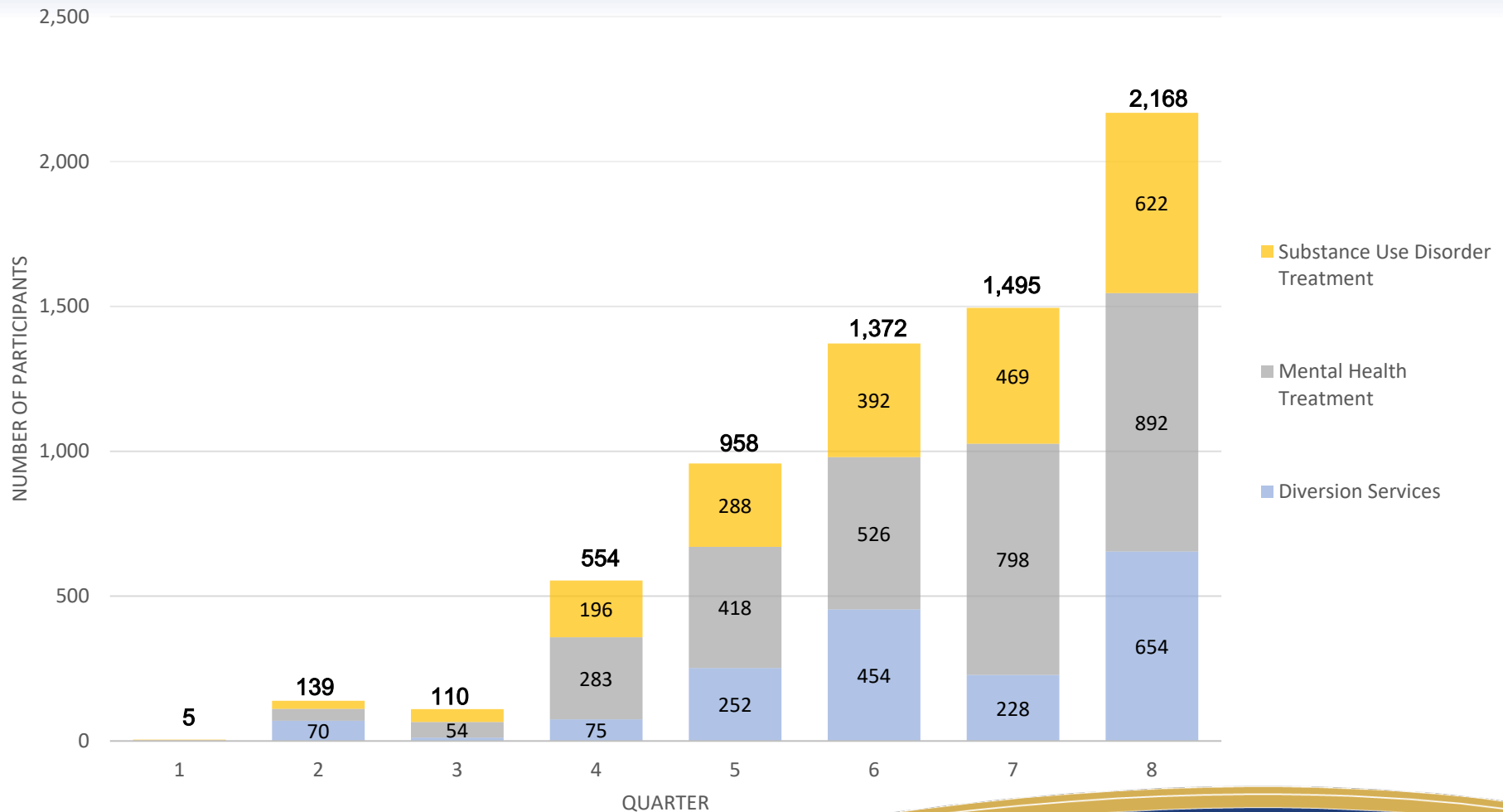
COHORT II HOUSING STATUS AT ENROLLMENT



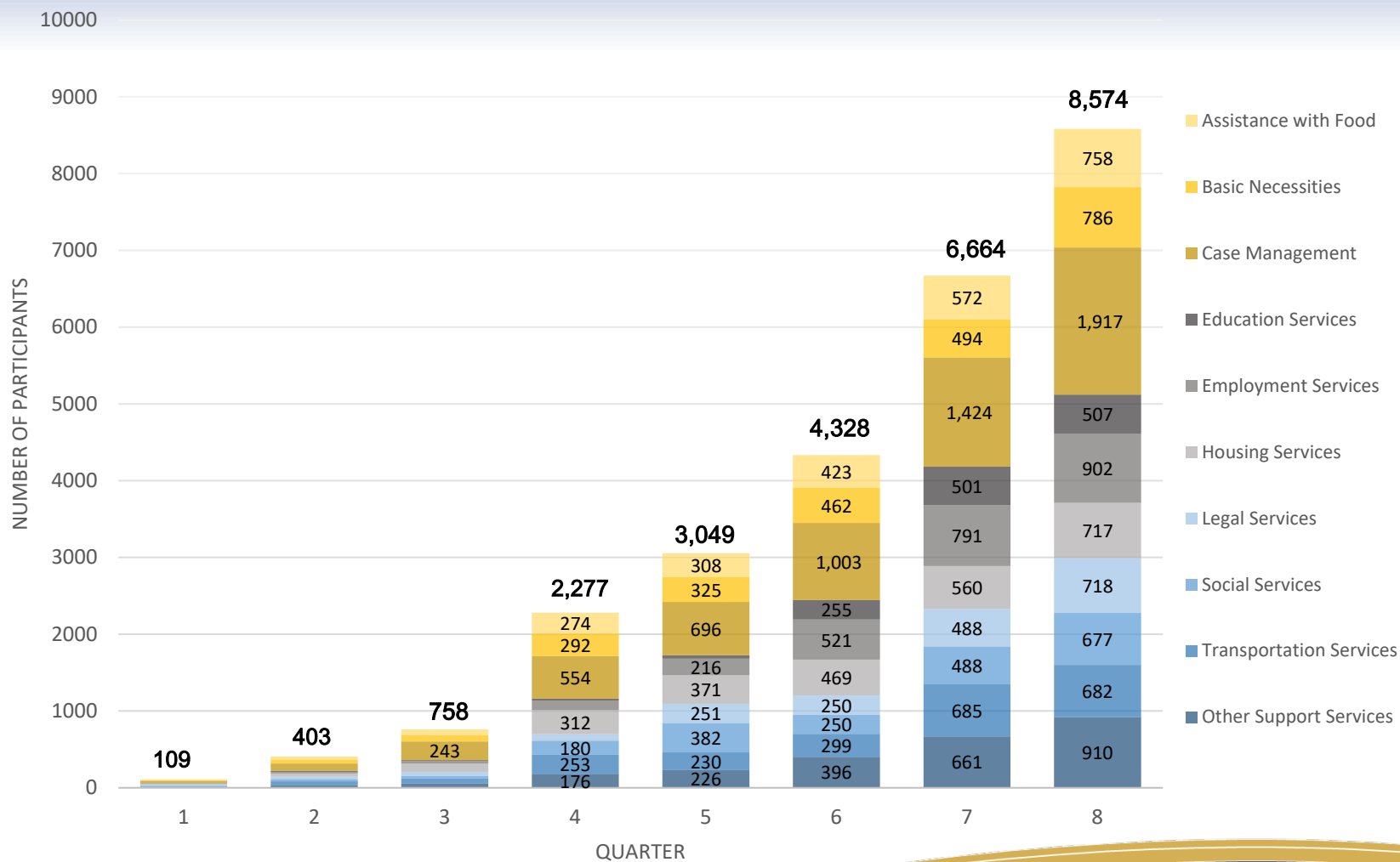
COHORT II EMPLOYMENT STATUS AT ENROLLMENT

COHORT II SUPPORT SERVICES BY QUARTER

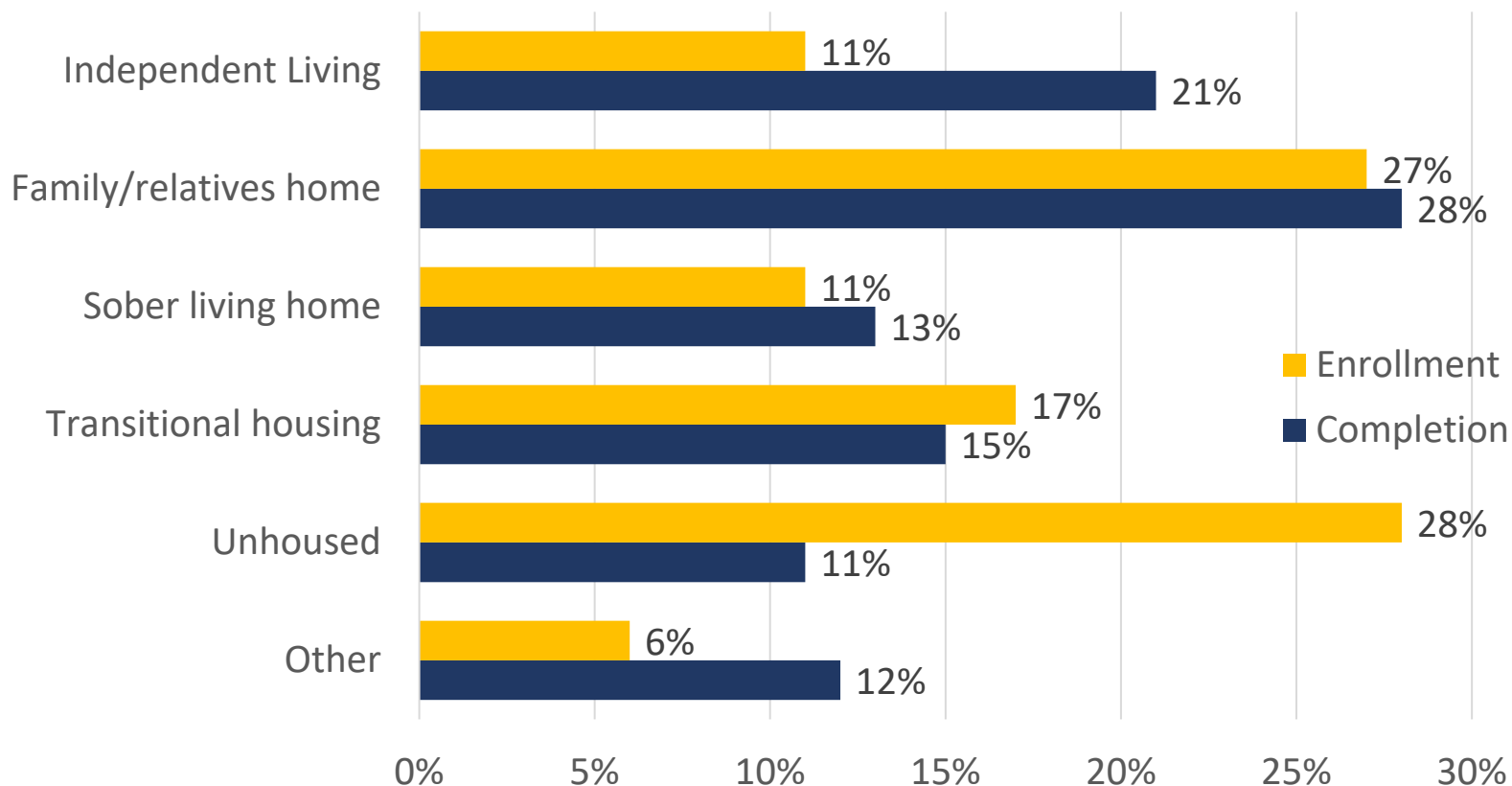

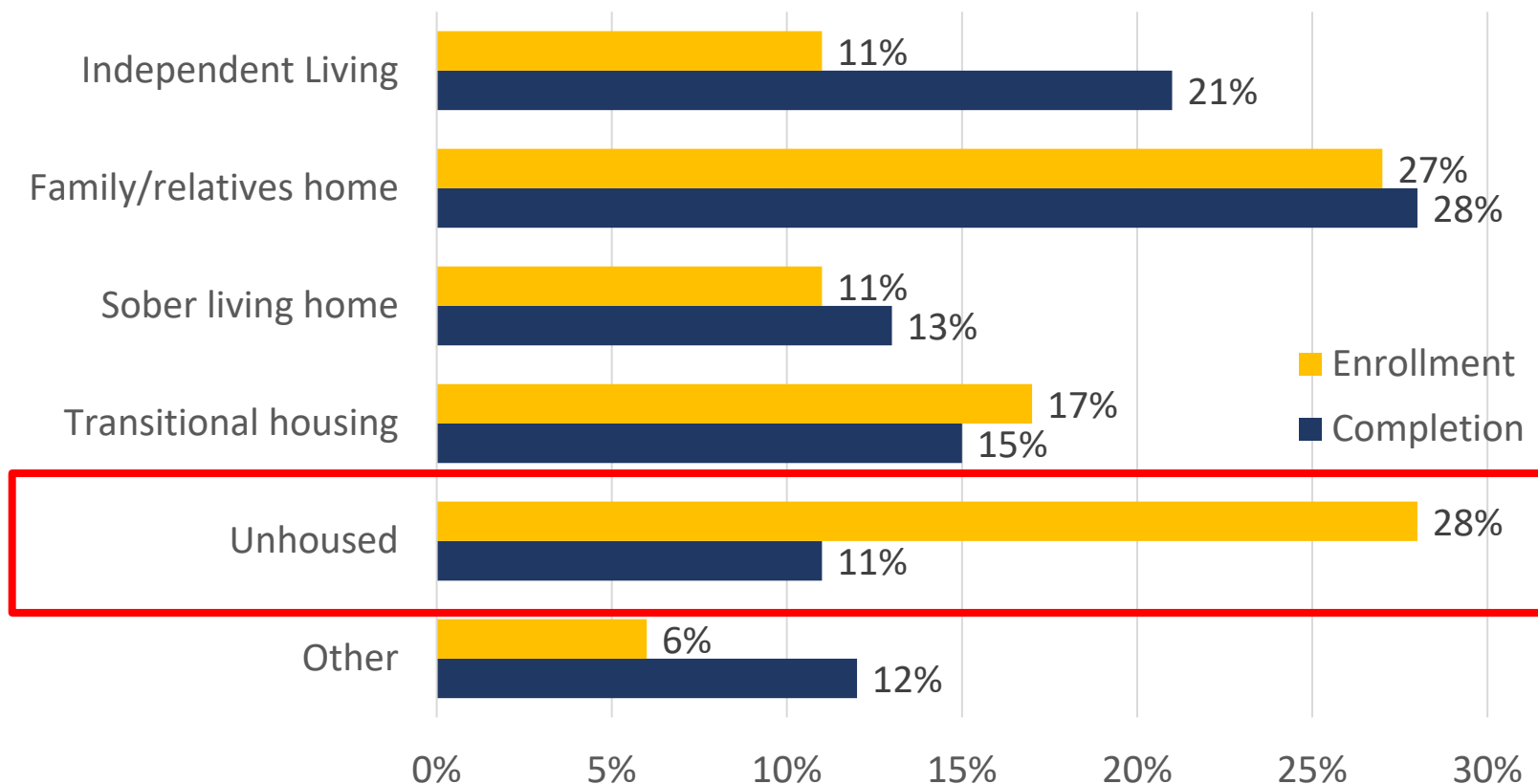
HOUSING STATUS CHANGE

Participants who have completed program and reported that housing was a goal ($n = 364$).



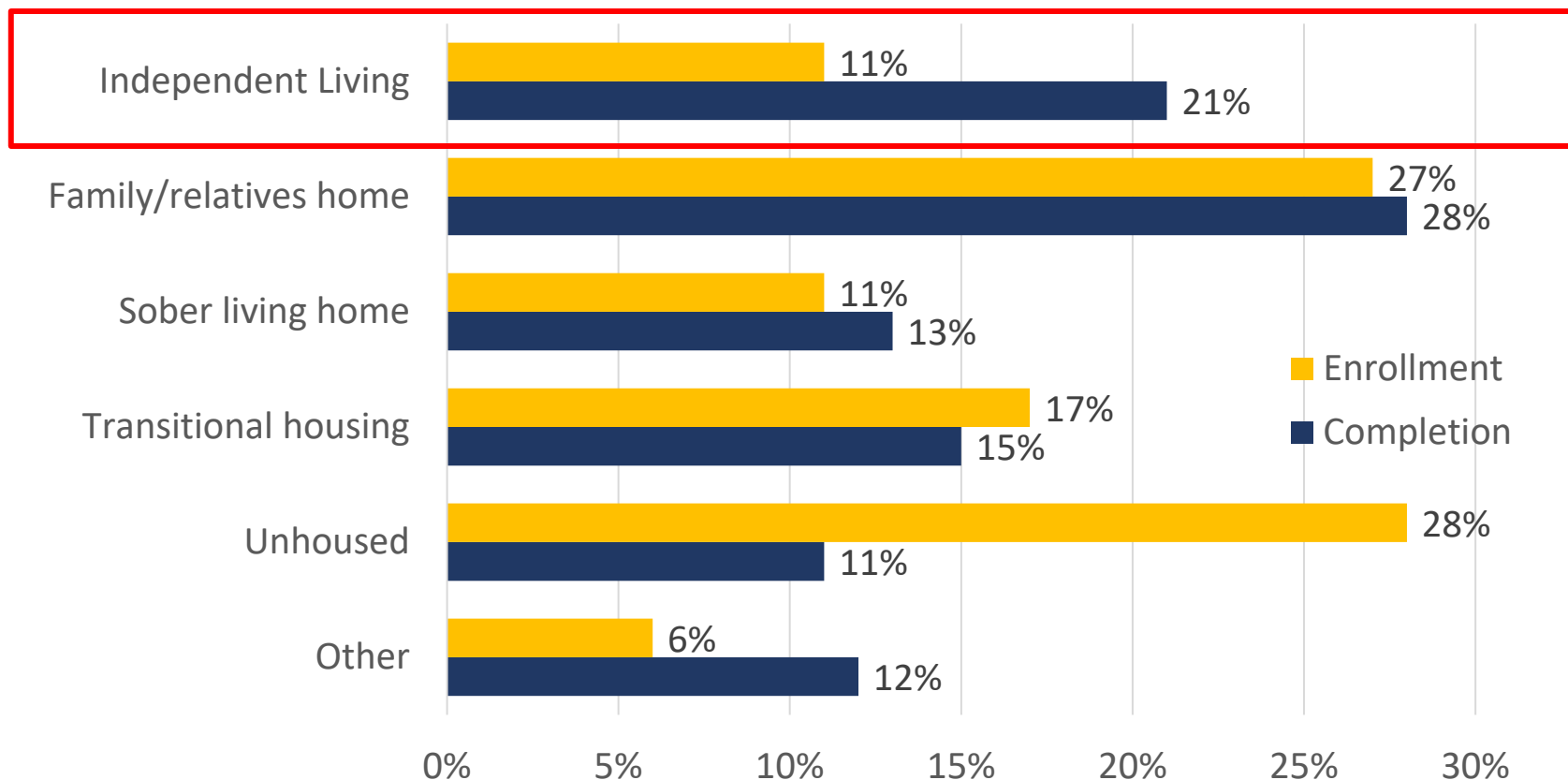
HOUSING STATUS CHANGE

Participants who have completed program and reported that housing was a goal ($n = 364$).



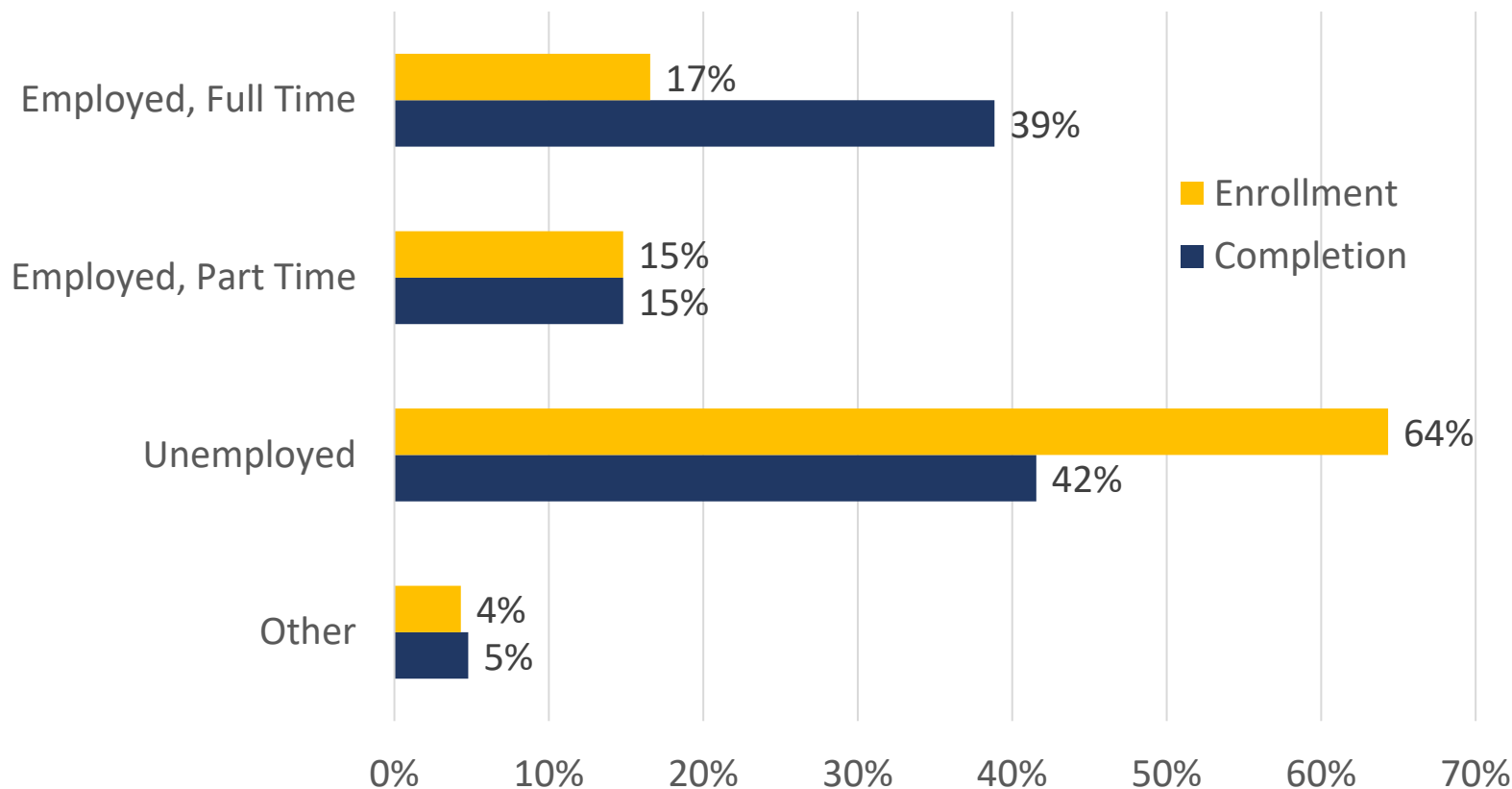
HOUSING STATUS CHANGE

Participants who have completed program and reported that housing was a goal ($n = 364$).



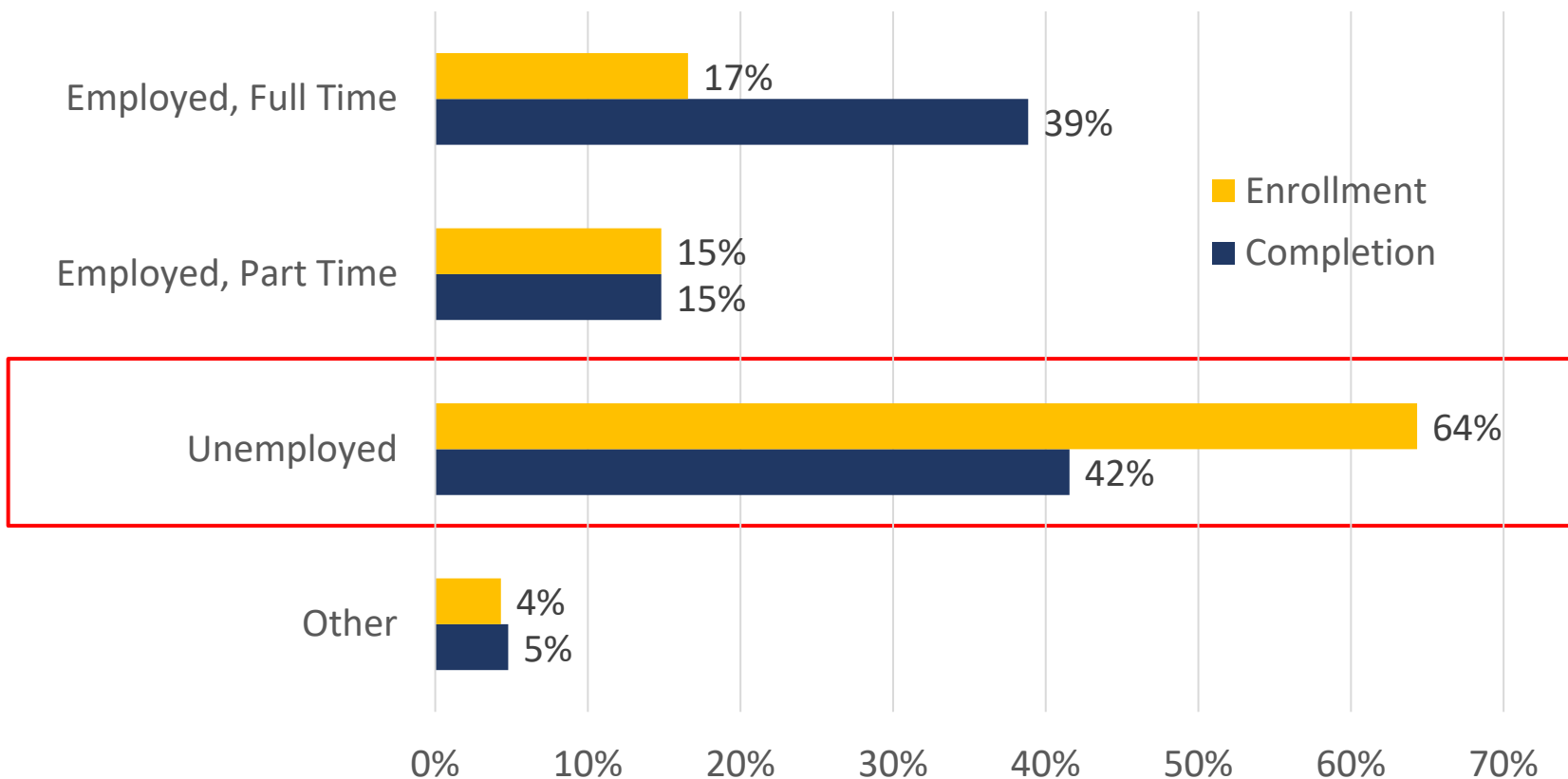
EMPLOYMENT STATUS CHANGE

Participants who have completed program and reported that employment was a goal. ($n = 628$)



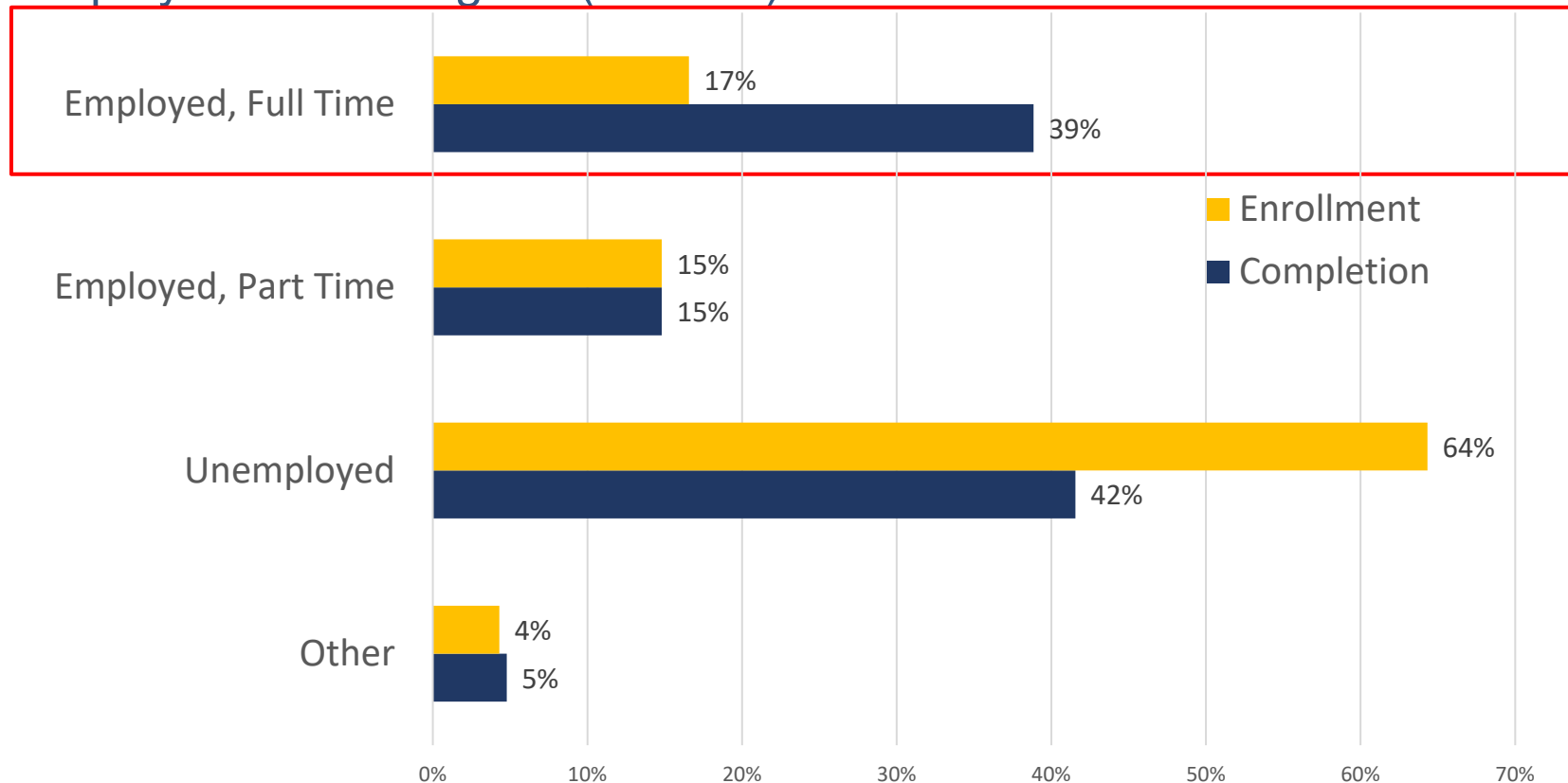

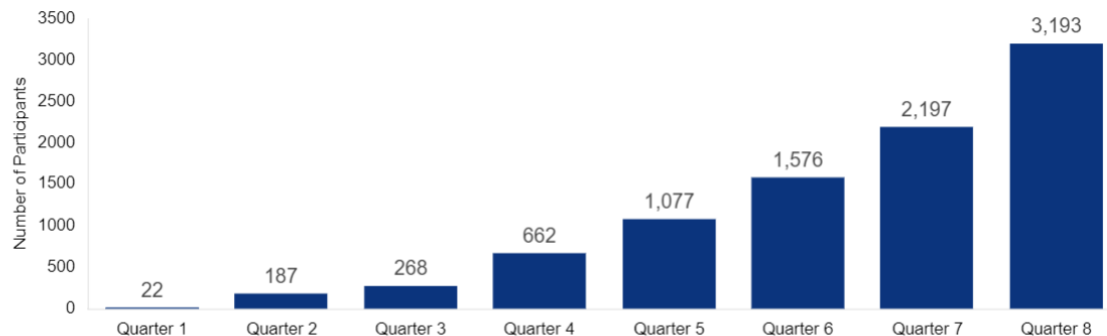
