# California Violence Intervention and Prevention Grant (CalVIP) ESC Seeking Membership

The Board of State and Community Corrections (BSCC) is seeking members to serve on a new Executive Steering Committee (ESC) for the **California Violence Intervention and Prevention** (CalVIP) Grant. (Note: Members of the 2017-18 CalVIP ESC will be given priority consideration.) Statements of Interest for this ESC membership must be submitted by <u>August 23, 2019</u>. *Please read below for more information*.

#### **About the CalVIP Grant**

The Budget Act of 2019 (Assembly Bill 74, Chapter 23, Statute of 2019) appropriated a total of \$30 million in funding for the CalVIP grant program. Of this, \$9 million is ongoing, \$18 million is one-time and an additional \$3 million is one-time with a specific focus on rural communities. Funding in subsequent years is expected to be \$9 million beginning in Fiscal Year 2020/21.

Pursuant to AB 74, the Board of State and Community Corrections is required to award competitive grants to California cities and community-based organizations (CBOs) to support violence intervention and prevention initiatives. The City of Los Angeles may apply for up to \$1 million on a non-competitive basis. All successful city applicants must pass through to one or more CBOs a minimum of 50 percent of grant funds received. All successful applicants must provide a 100 percent cash or in-kind match to support and enhance activities funded by the grant.

# **Considerations for CalVIP ESC Membership**

- Professional and/or personal life experience or subject matter expertise. BSCC seeks
  members who have professional expertise and/or personal life experiences related to
  community-based violence intervention initiatives, program evaluation, policy
  development and/or advocacy. Specifically, BSCC seeks:
  - Persons with direct experience (with either a governmental agency or a community-based organization) in implementing evidence-based violence reduction initiatives, including initiatives that incorporate public health and community-based approaches.
  - Persons who have been impacted by violence.
  - Formerly incarcerated persons.
- <u>Diversity</u>. BSCC seeks members who will represent California's population and its diverse racial, ethnic, geographic, gender and cultural perspectives and backgrounds.

Note: Prior experience on an ESC is not required.

## Responsibilities of the CalVIP ESC

Individuals interested in serving on the CalVIP ESC should be prepared to:

- Attend several all-day meetings (dates TBD, but likely to be held in September and/or October) to develop a Request for Proposals (RFP) for Board approval;
- Read and score the proposals that are submitted to develop award recommendations for Board approval.

## **Membership Term**

Members of the ESC will be appointed by the Board on a limited term beginning in September 2019 and concluding in June 2020.
