- Provide Incentives for participation of \$x gift cards in meetings for youth and family members who have had contact with the juvenile justice system.
- Prepare the system involved youth participants in advance of the meeting.
- Identify programs that have changed the life of the youth engaged in the juvenile justice system.
- Identify programs that have worked in reducing recidivism.

DELIVERABLES

- 1) Hold at least (1) one community meeting(s) to discuss the local juvenile justice program needs at all points of contact for Juveniles under the age of 26 and their families. This meeting may be virtual or in person if allowable in your community.
- 2) Develop a written report of no more than five pages on findings from the community input meetings provided to BSCC by May 17, 2021. The report must include; xxx
