2	AB 268 Board of State and Community Corrections Assemblymember Weber, M.D., Akilah (D-79)	INTRODUCED: January 23, 2023 This bill would add two additional members to the Board, a licensed health care provider and a licensed mental health care provider, appointed by the Governor, subject to Senate Confirmation. This bill would also require the Board to develop and adopt regulations pertaining to standards of care for incarcerated persons with mental health issues by local correctional facilities, including requirements for training of correctional staff in-service training of correctional officers shall include no fewer than four hours of training on mental and behavioral health annually. Requirements for mental health screening, and requirements for safety checks of incarcerated persons shall be sufficiently detailed to determine the safety and well-being of the incarcerated person, and that they are not in distress. 3	AB 280 Segregated confinement Assemblymember Holden, Chris (D-41)	INTRODUCED: January 24, 2023 This bill would require every jail, prison, public or privately operated detention facility, and a facility in which individuals are subject to confinement or involuntary detention to develop and follow written procedures governing the management of segregated confinement. Would prohibit involuntarily placing an individual in segregated confinement if the individual belongs to a special population, including, among others, that the individual has a mental or physical disability or that the individual is under 26 years of age or over 59 years of age. Require the facility to additionally periodically check on the individual and have a medical or mental health professional periodically assess the individual. Require a facility to offer out-of-cell programming to individuals in segregated confinement for at least 4 hours per day. Authorize a facility to use segregated confinement to help treat and protect against the spread of communicable disease and other specified provisions. The Board of State and Community Corrections will be required to assess each local correctional facility for compliance.
