These code sections both call for a consolidated report format that includes a description of the programs and other activities supported by JJCPA and/or YOBG funds, an accounting of all JJCPA and YOBG expenditures during the prior fiscal year, and countywide juvenile justice trend data.

Prior to submitting this report save the file using the following naming convention: "**(County Name) 2019 JJCPA-YOBG Report.**" For example, Yuba County would name its file "Yuba 2019 JJCPA-YOBG Report".

Provide a summary description or analysis, based on available information, of how the programs, placements, services, strategies or system enhancements funded by JJCPA-YOBG have, or may have, contributed to, or influenced, the juvenile justice data trends identified in this report.

In the past, YOBG funds were used primarily for the Juvenile Hall Youth. JJCPA funds were used to help fund programs for Alternative education and a Community Based Organization, Healthy Communities, for after school activities. In 2008, Inyo County, began developing and using Evidence Based Practices (EBP) for our Juvenile Hall Programs using YOBG funds. Since that time we began to see less recidivism with youth returning to our Juvenile Hall. Due to decreasing numbers of Youth being arrested, detained, and committed to our Juvenile Hall, a decision was made to convert our Full Service Juvenile Hall into a 96 hours Special Purpose Juvenile Hall, using it mainly for weekend commitments. We changed to titles of our highly trained Group Counselors, to Rehabilitation Specialists, with the intent to use them to provide services to out of custody Youth and adults. Beginning on September 22, 2016, our Rehabilitation Specialists began serving a broader population of youth in Inyo County. We began using YOBG funds to serve, out of custody, high/at risk Youth with EBP Early Intervention programing in three local High Schools to help distance these Youth from the criminal justice system. Due to the success, what began as a Pilot Program has evolved into serving 8 schools in Inyo County with Early Intervention Services for high/at risk Youth with the use of YOBG and JJCPA funds.

Vocational Education—Extending the School Day

The Juvenile Justice Grant allows JKBS to have a full school day for at-risk students. The grant helps to fund instructors to teach a variety of elective/vocational classes during the afternoons.

Odyssey ware

Odyssey ware is an online curriculum program that allows JKBS to offer a wider variety of courses to students. Most of the students who come to JKBS are credit deficient, by integrating Odyssey ware into our regular curriculum; we are better able to meet the academic needs of the students.

Drug Dogs—Insuring a Drug-free Campus

Beginning with the 2009/10 school year, Inyo County Superintendent of Schools, along with several other districts in the county, began contracting with Interquest to have drug sniffing dogs come to the school. JKBS has four random visits from the dogs, funded by the Juvenile Justice grant, throughout the school year. The students sit through a presentation about the dog program and are aware that they the dogs can visit campus at any time. The students are familiarized with the practices and procedures for a search. The students are put on notice that they can be effectively searched at any time and that JKBS does not tolerate drugs or alcohol on campus.

All at risk youth will be screened and assessed, including all youth in the Early Intervention programs. The Change Companies evidence based journals have been purchased with YOBG funds and used in conjunction with this case plan by staff. Probation Officers staff will work with Rehab Specialists to develop case plans which will include Substance Abuse and Anger Management counseling as well as the Power Source Program. Case plans would include contracts with Private Mental Health Providers. The Forwarding Thinking, and the KIDS interacting journaling series will continue to be used for a variety of counseling services that will include Alcohol and Drug and Anger Management, among others. These 2 series plus a few others use over 30 different evidence based interactive journals. The case plans will include UA testing and supplies to prove sobriety and family reunification plans.
