LEADERSHIP

- ❖ **Lead Agency: Create and sustain a model that keeps internal and external partners on the same page (e.g. program and fiscal staff, evaluators & providers)**



COMMUNICATION

- ❖ Ensure internal and external partners are familiar with:
 - ✓ Project Goals
 - ✓ Referral Processes
 - ✓ Key Contacts and When to Contact
 - ✓ Key Activities and Dates



MODEL INTEGRITY

- ❖ What steps are in place to prevent variance from the grant-funded model?
- ❖ What does a quality control plan look like for your program?



LOCAL ADVISORY COMMITTEE (LAC)

- ❖ **The Prop. 47 LAC must include a broad range of stakeholders.**
- ❖ **The Lead Agency must:**
 - **Host regular community meetings**
 - **Maintain documentation of public outreach efforts, attendance, agendas and minutes.**

PROGRESS REPORTS

- ❖ Provides a written account of project milestones, progress and challenges.
- ❖ Accessible from the BSCC website
 - Microsoft Word and Excel
 - Email completed reports to:
BSCCProp47Grants2@bscc.ca.gov
- ❖ Reporting system/process may change in 2020.

RECIDIVISM DEFINED

- ❖ Cal. Penal Code § 6046.2(d))
- ❖ “A conviction of a new felony or misdemeanor committed within three years of release from custody or committed within three years of placement on supervision for a previous criminal conviction.”
 - **“Committed” refers to the date of offense, not the date of conviction.**

RECIDIVISM TRACKING

- ❖ At a minimum, “recidivism reduction” must be a project outcome measure.
- ❖ May use an alternate definition in addition to the Penal Code definition.
- ❖ Begin local discussions on how to collect/track recidivism ASAP.

PROGRAM MODIFICATIONS

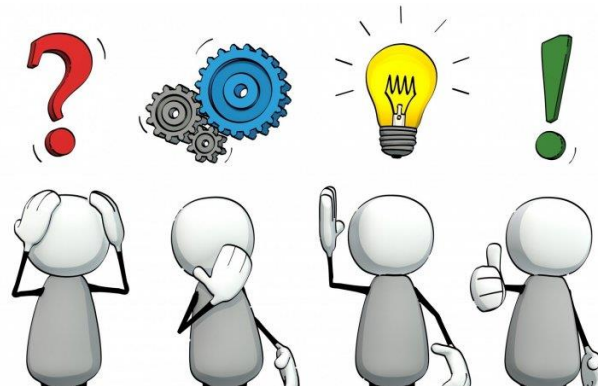
- ❖ **Reserved for substantive changes in project scope and specific program components.**
- ❖ **Discuss proposed change(s) with Field Representative prior to submission.**
- ❖ **Requires detailed narrative and must be submitted by the Project Director.**
