# Proposition 47 Grant Program Executive Steering Committee Seeking Membership

The Board of State and Community Corrections (BSCC) is seeking members to serve on a new Executive Steering Committee for the Proposition 47 Grant Program. Statements of Interest for this ESC will be taken until <u>Friday</u>, <u>October 22</u>, <u>2021</u> or until a full membership has been reached.

### **Proposition 47 Grant Program**

Proposition 47 was a voter-approved initiative on the November 2014 ballot that reduced from felonies to misdemeanors specified low-level drug and property crimes. Each year, the state savings generated by the implementation of Proposition 47 are deposited into the Safe Neighborhoods and Schools Fund. Sixty-five percent of these savings are set aside annually for the BSCC to administer a competitive grant program.

The BSCC anticipates that in FY 2021 approximately \$75.3 million will be available for competitive awards. Additionally, in FY 2022-23, the BSCC anticipates receiving a similar amount in the annual deposit (approximately \$75.7 million) After accounting for administrative costs, this means that cohort 3 will have approximately \$142.5 million available for Prop 47 grants.

Proposition 47 requires that these funds be awarded to public agencies to provide mental health services, substance use disorder treatment and/or diversion programs for those in the criminal justice system. Additional legislation (AB 1056, Chap. 438, Stats. of 2015) requires that the grants be awarded competitively, specifies that funds may serve both adults and juveniles, and allows funds to be used for housing-related assistance and other community-based supportive services, including job skills training, case management or civil legal services.

## Interested in participating on the Proposition 47 ESC?

The BSCC is forming an ESC that reflects California's diverse population in terms of perspectives, backgrounds, professional expertise, life experiences, and geographical representation. AB 1056 further requires that the ESC have expertise in homelessness and housing, behavioral health and substance abuse treatment, and effective rehabilitative treatment for adults and juveniles. Prior experience on an Executive Steering Committee is not a requirement to serve on the Proposition 47 ESC.

#### **Responsibilities of the Proposition 47 ESC**

There are important responsibilities and considerations that you <u>must</u> review before determining whether you can serve on this ESC, such as:

- Time commitment;
- Conflict of Interest Laws;
- Financial Reporting Requirements; and
- Ethics Training

Individuals interested in serving on the Proposition 47 ESC should be prepared to attend multiple all-day Zoom meetings or potential in person meetings. Meetings are tentatively scheduled for November 16-17, 2021, December 3, 2021, and May 24, 2022. If selected to serve on the ESC you will help develop the Request For Proposals (RFP), participate in a virtual proposal rating training and individually read and score the proposals that are submitted to develop award recommendations for BSCC Board approval. If needed, additional virtual meetings may be scheduled to ensure key activities are completed.
