MISSION

Core Principles:

Strategy – a coalition of knowledgeable stakeholders and communities, current or former wards, and local elected officials;

Advocacy – a plan to prevent juvenile delinquency while providing treatment and rehabilitation for youthful offenders; and

Compliance – a means of monitoring program compliance and ensuring adherence with the core protections of federal law.

SACJJD***P Accomplishments***

Since its reconstitution in February 2007, the California SACJJD has provided exemplary leadership within juvenile justice in a state that has an enormous and highly diverse youth population. Through the identification of state priorities and the oversight of the distribution of multi-million dollars in grant funding for youth-serving programs, examples of the SACJJD's accomplishments include:

- Title II Delinquency Prevention and Intervention Program; \$4.6 Million
- Juvenile Accountability Block Grant Program; \$2 Million
- Evidence-Based Programming Partnership with Administrative Office of the Courts and Assessments.com; \$1.7 Million
- Enhanced DMC-Technical Assistance Program; \$1.1 Million
- DMC Support Grants; \$600,000
- DMC Multi-Discipline Curriculum Development; \$140,000
- Anger Management and Youth Violence Prevention Training Project (Governor's Gang Initiative - California's Gang Reduction and Intervention); \$1.1 million
- DMC Regional Training for School Attendance Review Board Partnership; \$139,000
- Native American/Tribal Youth Program; \$240,000
- DMC School District- Pilot Project; \$50,000
- DMC Police Curriculum- Pilot Project; \$0

Within the current SACJJD Strategic Plan, the following five focus areas have been identified as priorities:

EVIDENCE-BASED PROGRAMS/ PROMISING APPROACHES

Goal: Improve juvenile justice system efficiency/effectiveness and lower the arrest and recidivism rates through the increase use of Evidence-based/ promising approach programs.



HOLISTIC APPROACH TO COUNSEL

Goal: Promote quality legal defense representation of youth in the juvenile delinquency system in California through well funded children's legal defense systems that emulate best or promising holistic legal practice models.

DISPROPORTIONATE MINORITY CONTACT (DMC)

Goal: Reduce the number of youth of color coming into contact with the juvenile justice system.

ALTERNATIVES TO DETENTION

Goal: Reduce the number of youth held in secure detention.

RESTORATIVE JUSTICE PRINCIPLES

Goal: Restore victims' wounds; restore offenders to law-abiding lives; and repair harm done to interpersonal relationships and the community.
