Proposal Summary	The Sonoma County District Attorney's (DA) Office proposes to establish the Organized Retail Theft Vertical Prosecution Unit (ORT VPU), a specialized unit that draws on the DA's Office's extensive experience implementing the True Vertical Prosecution Model. The DA's Office will dedicate one full-time Deputy DA and one full-time DA Investigator to investigate and prosecute all organized retail theft crimes that fall under Sonoma County's jurisdiction, in collaboration with local law enforcement and retailers association partners. The ORT VPU will expand data management infrastructure to enable the tracking, assessment, and improvement of the proposed program.

Project Need

1.1 Needs to be Addressed

In 2021, the National Retail Federation found that retailers saw a 26.5% increase in organized retail crime incidents from the prior year. Locally, incidents of organized retail theft in Sonoma County have cost businesses between \$1,000 to \$30,000 dollars of stolen merchandise. The costs of retail theft are felt by employees, who fear for their safety on the job, and consumers, who face price inflation. Main Streets, malls, and shopping centers are part of the fabric of any community. The Sonoma County District Attorney's (DA) Office is committed to addressing organized retail theft in these spaces to create a safer community for Sonoma residents.

Based on community interest in addressing retail theft, the DA's Office assessed the nature of need in Sonoma County. Sonoma is home to a large volume of theft cases in general, and since 2021 has filed 13 organized retail theft cases as defined by Penal Code section 490.4. However, investigations of organized retail theft cases are extremely labor intensive. Furthermore, law enforcement reports that

many of the individuals in these cases committed the crime in Sonoma County but live outside of the County: of the 13 cases filed in Sonoma County since 2021, only three defendants reside in the County. Organized retail theft puts employees and shoppers at risk, and harms the overall Sonoma County community. Implementing a vertical prosecution model will enable the DA's Office to address the issue of organized retail theft to ensure a safe and thriving community.

The DA's Office proposes to establish the Organized Retail Theft Vertical Prosecution Unit (ORT VPU), a specialized unit addressing organized retail theft cases. The DA's Office will dedicate one full-time Deputy DA and one full-time DA Investigator to investigate and prosecute all organized retail theft crimes that fall under Sonoma County's jurisdiction. The ORT VPU will target all of Sonoma County, with a particular focus on major retail centers in larger cities like Santa Rosa and Petaluma. Law enforcement reports that there are fewer instances of organized retail theft in rural areas of the county, as thieves target high-end brands that they can easily resell.

1.2 Local Data Demonstrating Nature and Scale of the Organized Retail Theft Problem

In February 2020, the Sonoma Index-Tribune reported on a string of local thefts that included \$35,000 in merchandise being stolen from Lululemon and \$13,000 from American Eagle Outfitters. These organized retail thefts were part of a broader Bay Area and California crime trend in which name-brand clothes are resold on online black markets. Favored targets include stores carrying name-brand clothes, makeup, and other high-end consumer products. Stolen clothing is not serialized and therefore extremely difficult for investigators to trace. As introduced in Section 1.1, since 2021 the Sonoma County DA's Office has filed 13 organized retail theft cases as defined by Penal Code section 490.4. Locally, incidents of organized retail theft range from large-scale theft activities as part of a ring, to repeated theft incidents over one day by the same individuals. Some incidents have involved weapons and stolen vehicles, and have cost businesses between \$1,000 to \$30,000 of stolen merchandise.

1.3 Existing Hurdles of Implementing a Vertical Prosecution Model Implementing vertical prosecution to address organized retail theft is a radical new approach. Vertical prosecution has been demonstrated to improve conviction rates, reduce victim trauma, and provide more consistent and appropriate sentencing. However, the Sonoma County DA's Office currently lacks adequate funding or staff to implement an ORT VPU. The DA's Office has extensive experience establishing and implementing vertical prosecution units to address domestic violence and sexual assault, and driving under the influence of drugs and/or alcohol. Bureau of State and Community Corrections (BSCC) Organized Retail Theft Vertical Prosecution Grant Program funds will enable the DA's Office to leverage its experience implementing this evidence-based prosecution approach in a new way.

Project Description

2.1 Vertical Prosecution Methodology

The DA's Office proposes to establish the Organized Retail Theft Vertical Prosecution Unit (ORT VPU), a specialized unit addressing organized retail theft cases. The DA's Office will dedicate one full-time Deputy DA and one full-time DA Investigator to investigate and prosecute all organized retail theft crimes that fall under Sonoma County's jurisdiction. The ORT VPU will target all of Sonoma County, with a particular focus on major retail centers in larger cities like Santa Rosa and Petaluma. Law enforcement reports that there are fewer instances of organized retail theft in rural areas of the county, as thieves target high-end brands that they can easily resell.

The Sonoma County DA's Office has extensive experience implementing the True Vertical Prosecution Model, in which the same prosecutor handles every part of the judicial process, from arraignment to sentencing. For this program, we anticipate utilizing the Major Stage Vertical Prosecution Model, in which the vertical attorney files the charges or makes the first appearance for cases where charges meet the necessary criteria for vertical prosecution, and is present for all significant appearances, such as: preliminary hearing, trial, sentencing, contested motions affecting bail, admissibility of evidence, dismissal of charges, change of venue, motions to sever or consolidate, discovery, set aside the verdict, or motions concerning search warrants. This prosecution model provides the opportunity for the assigned attorney to allow for the realities of case management and avoid conflicts and delays.

As part of the ORT VPU, the DA's Office will create a "case type" for retail theft cases in order to track all instances of retail theft. When retail theft cases are referred to the DA by law enforcement, data entry staff will identify these cases and assign the newly created case type for tracking purposes. All retail theft cases will be assigned to the designated vertical prosecutor and DA investigator. Data entry staff will be trained on the grant requirements to ensure that all pertinent details for tracking ORT cases will be entered into the case management system to ensure accurate reporting of the grant project.

The Sonoma County DA's Office has observed that the vertical prosecution model enables staff to become experts in investigating and prosecuting that particular type of crime. They develop a deep understanding of the nuances of the law and forge strong relationships. The DA's Office has found that victims are more likely to participate in a case if they have a single point of contact. Further, vertical prosecution enables the DA's Office staff to develop ongoing partnerships with law enforcement. These partnerships are strengthened by the fact that all Sonoma County Investigators are former law enforcement officers with close ties to local police at all levels. ORT VPU staff will partner with the Sheriff's Office and other County law enforcement agencies, City police agencies across the

county, and California Highway Patrol.

Implementing a Major Stage Vertical Prosecution Model will improve conviction rates, victim satisfaction with prosecutorial outcomes, and more consistent and appropriate sentencing. ORT VPU staff will also partner with retailers associations like Chambers of Commerce to provide outreach to victims and share information about the vertical prosecution model. The DA Investigator will collaborate with law enforcement, who will be responsible for working with online marketplaces and retailers to address organized retail theft.

The DA's Office proposes to reduce recidivism through creative approaches to diversion through the Sonoma County District Attorney Restorative Justice Program. Where possible, the DA's Office will pursue alternatives to incarceration through the Restorative Justice Program.

2.2 Proposed Goals and Objectives

The proposed Sonoma County ORT VPU will achieve the following goals: 1) Develop infrastructure necessary to successfully establish, implement, and track the grant program; 2) Increase public safety in retail spaces; 3) Strengthen prosecutions of organized retail theft; and 4) Reduce recidivism among individuals charged with organized retail theft in Sonoma County.

Goal 1 will be accomplished by creating a "retail theft" case type in the DA grant management system to track all retail theft cases, ensure case assignment to the designated prosecutor and investigator, and create the foundation for accurate reporting for the project. Goal 2 will be supported by visible partnerships between the DA's Office, law enforcement and retailers associations to align efforts and communicate to community members that the County is working to address the issue of organized retail theft. Sonoma County residents are stressed and scared to work and shop at retail stores, and the ORT VPU will demonstrate that this issue is not being overlooked, increasing resident trust in government agencies. To achieve Goal 3, the vertical prosecution model employed by the ORT VPU will strengthen prosecutions of individuals who commit organized retail theft crimes and consistent sentencing of these crimes. As a specialized unit, the Investigator and Deputy DA will be deeply knowledgeable in investigating and prosecuting organized retail theft cases. The single point of contact will increase trust among victims and witnesses, leading to greater participation in the case. Finally, the ORT VPU will promote reduced recidivism through Goal 4 by referring cases to the Restorative Justice Program, as applicable.

The proposed project will rely heavily on new legislation that allows prosecutors to charge a felony rather than a misdemeanor in certain circumstances, which will help hold offenders accountable for the aggregate value of the merchandise stolen at multiple locations on multiple dates. Prior to this new legislation, theft of less than \$950 worth of goods could only be prosecuted as a misdemeanor, making

it a low-risk crime with negligible consequences. The partnerships created with law enforcement and retailers will encourage the sharing of information and reporting of incidents of theft in order to determine repeat offenders who can be held accountable to a greater degree under this new legislation.

Effective January 1, 2023, Penal Code Section 487 was amended to add a new subdivision (e), that reads as follows: "If the value of the money, labor, real property or personal property taken exceeds nine hundred fifty dollars (\$950) over the course of distinct but related acts, the value of the money, labor, real property, or personal property taken may be aggregated to charge a count of grand theft, if the acts are motivated by one intention, one general impulse, and one plan."

2.3 Rationale for Proposed Project

The Golden Gate University School of Law Review found that vertical prosecution is the better option for justice because it is more efficient than horizontal prosecution and meaningfully involves the victim. Because vertical prosecution is shown to improve conviction rates, reduce victim trauma, and provide more consistent, appropriate sentencing, the Sonoma County DA's Office has established and maintained vertical units to prosecute sexual assault and domestic violence crimes against women, and Driving Under the Influence (DUI) crimes in the county. Since establishing these units, the DA's Office has seen improved victim participation, particularly in violent crimes against women who can be fearful about participating in prosecution, leading to more successful prosecutions. Victim participation also provides the opportunity for better understanding of the legal process and increases victim satisfaction with outcomes. Attorneys and investigators assigned to vertical prosecution units develop expertise in the subject matter through project-oriented training and experience, and provide advice and mentorship in their area of expertise. The implementation of a vertical prosecution program for retail theft cases will create an expert Deputy DA/DA Investigator team for retail theft crimes and create more uniform, equitable results in court.

3.1 Project Organizational Capacity and Coordination
The Sonoma County DA's Office will leverage its experience in
managing vertical prosecution programs to implement the proposed
project. The Sonoma County District Attorney, Carla Rodriguez, has
played an active role in the project design. The ORT VPU is fully
aligned with the identified goals of the DA's Office, particularly in
collaboration with law enforcement partners to improve upon the
successful investigation and prosecution of crime in the county.

The proposed project will fund necessary additional staff time for three strategic positions in the DA's Office: 1.0 FTE Deputy DA, 1.0 FTE DA Investigator, and 0.2 FTE Department Analyst. These positions will provide for project oversight, coordination with law enforcement agencies in the region, training of local law enforcement officers in the vertical prosecution approach, outreach to retailers associations, coordination of data collection and evidence sharing, intensified investigation, and preparation of cases for prosecution.

The DA's Office will leverage the time of the Administrative Services Officer, who will lead the hiring process for the new Deputy DA and DA Investigator, and a Chief Deputy District Attorney and Chief Investigator, who will provide oversight for the project. The DA's Office will also leverage resources to enhance the capacity of the current case management system and evidence storage technology, which will play a key role in the collection and sharing of evidence with local law enforcement both countywide and regionally.

3.2 Partner Agencies and Coordination Necessary to Implement the Proposed Project

The DA's Office has established partnerships, outlined in Memorandums of Understanding (MOUs), with local law enforcement agencies, City police departments, other county agencies, and California Highway Patrol (CHP).

The proposed project will build upon these relationships to address organized retail theft in Sonoma County. The Sheriff's Office recently applied for BSCC funding through the Organized Retail Theft Prevention Program to pilot an in-vehicle dual-view camera program, which includes automated license plate reader capability. This technology has been effective statewide to identify groups t committing organized retail theft crimes. Other local agencies, including Santa Rosa Police Department and Petaluma Police Department, have also developed proposals for the BSCC Organized Retail Theft Prevention Program. The DA's Office will work with these targeted programs to reach the goals of the project. The DDA/DAI will also work with the CHP in their established task force created to identify organized retail theft rings and the distributors who drive the black market for the stolen goods.

3.3 Timeline for Execution of Contracts or Memorandums of Understanding

The Sonoma County DA's Office has an existing Victim Services MOU with all county and city law enforcement agencies that will be leveraged for the proposed project, ensuring that partners share information as it relates to cases. The ORT VPU will outreach to law enforcement and retailers association partners to identify the point of contact in the DA's Office related to organized retail theft. If funded, the DA's Office will be immediately ready to proceed with the proposed project.

3.4 Management Structure

Sonoma County District Attorney, Carla Rodriguez, will be the ultimate authority for the proposed project. The in-kind Administrative Services Officer will supervise the Department Analyst and lead the hiring process. The in-kind Chief Deputy DA and Chief Investigator will train the Deputy DA and DA Investigator, and provide

high-level oversight of the proposed project, including reviewing Quarterly Progress Reports and overseeing the assigned vertical Deputy DA and DA Investigator. The assigned Deputy DA and DA Investigator will regularly coordinate to make day-to-day decisions for the ORT VPU.

3.5 Plans to Sustain Project after Grant Funds Expire
The project will facilitate expanded collaboration and communication
with law enforcement, which will continue well beyond the end of the
grant period. The data system and the system enhancements
developed for the project will persist after grant funding concludes.
Continuing the vertical prosecution model will depend upon County
resources. A successful program may encourage the Board of
Supervisors to provide funding to support the project in the future.

Project Evaluation and Monitoring

4.1 The Plan

The Department Analyst will be responsible for the Quarterly Progress Reports to BSCC, participation in the statewide evaluation, and the development of the Local Evaluation Plan and Local Evaluation Report. Joan Croft will serve as the 0.20 FTE Department Analyst. She has worked for the DA's Office since 2017 and has experience managing two vertical prosecution grant programs: Vertical DUI Prosecution through the California Office of Traffic Safety, and Violence Against Women Vertical Prosecution through California Office of Emergency Services. Ms. Croft will be responsible for the initial implementation and monitoring of the project utilizing the DA case management system, Prosecutor by Karpel (PBK). Data will be collected each quarter to provide detailed reports for the project.

4.2 Process and Outcome Measures

The DA's Office will use the following eight metrics to measure performance: 1) Number of ORT cases referred to the DA by law enforcement; 2) Number of organized retail theft cases filed; 3) Number of organized retail theft convictions obtained; 4) Sentences imposed for organized retail theft convictions; 5) Number of instances in which vertical production was used to obtain convictions; 6) Sentences imposed in instances in which vertical production was used to obtain convictions; 7) Number of theft-related property crimes that were charged but did not use vertical prosecution; and 8) Number of theft-related property crimes that were convicted but did not use vertical prosecution.

4.3 Plan for Monitoring the Project

Data will be continuously collected by the Department Analyst and reported to the ORT VPU and law enforcement partners on a regular basis. These metrics will be used to assess project performance and guide modifications to program strategy in order to increase the

success of the project. Required data will also be provided to BSCC through Quarterly Progress Reports to be available for inclusion in the statewide evaluation. Data entry staff will be trained to recognize retail theft cases when reports are received from law enforcement agencies. All cases that fall under the purview of the ORT program will be given the "Retail Theft" case type and assigned to the ORT vertical prosecutor and investigator. The DA case management system, PBK, will be utilized to track cases from receipt through sentencing and verification of completion of diversion programs. Reporting metrics for the program will be retrieved from the case management system through the case type designation as well as the assignment to the vertical prosecution team.

4.4 Plan for Collecting and Evaluating Data

The Department Analyst will utilize the PBK system to collect and evaluate data. Baseline data for instances of retail theft will not be available for analysis without the change in business processes and case tracking that will be implemented under this program. The proposed project will include the creation of detailed data entry enhancements and case designation that will allow for accurate and detailed tracking of all retail theft cases in the jurisdiction. The proposed project will leverage the bi-directional data sharing agreements the DA's Office has previously established with the local law enforcement consortium that includes Sonoma County Sheriff's Office, Santa Rosa Police Department, and several other agencies.

4.5 Research Methodology

Quantitative research methods will be used to aggregate data pertaining to the ORT VPU. Data for cases assigned to the program will be tracked at the following data points: receipt of report from law enforcement, further investigation, filing decision, case resolution, sentencing, and diversion program completion. These data points will enable the reporting of quantitative data for number of reports of retail theft incidents received from law enforcement, repeat offender, multiple victimizations for a single business victim, cases in progress and under investigation, cases filed or rejected, convictions, trials, pleas, cases resolved with alternatives to incarceration, and number of cases with diversion programs successfully completed.

Analysis of these data points throughout the project will show the evolution of the project from inception to completion. Continuous monitoring throughout the project will demonstrate the success of the DA's Vertical Prosecution program in conjunction with local law enforcement BSCC retail theft prevention programs.

The Organized Retail Theft Vertical Prosecution Unit (ORT VPU) will be composed of three staff: one new Deputy DA (to be hired), one new DA Investigator (to be hired), and the existing Departmen Analyst. The DA's Office will leverage additional staff time to support the project as needed, including the Administrative Services Officer to oversee the hiring process, and the Chief Investigator and

Chief Deputy DA to oversee training of new staff.

The 1.0 FTE Deputy DA will train local law enforcement on criteria that signify organized retail theft, provide information on the relevant legal statutes, oversee investigations up to the point of criminal filling, work with the DA Investigator to review evidence, and make recommendations to law enforcement regarding cases that merit further investigation. This attorney will also coordinate efforts and strengthen communication with local and regional law enforcement and retailers associations to prepare cases for prosecution. In addition, the Deputy DA will provide community outreach, including ress releases to inform the public about the activities of the ORT VPU, and public service announcements about the County's approach to addressing organized retail theft.

The 1.0 FTE DA Investigator will provide training for local law enforcement regarding investigatory strategies and techniques for gathering evidence regarding organized retail theft crime. The nvestigator will also serve as the primary DA's Office contact for law enforcement in retail theft cases. When a possible crime is reported by law enforcement, the Investigator will provide assistance and oversight related to obtaining witness statements, proper collection of evidence, and other activities to ensure that all of the elements of an investigation are complete for criminal prosecution. The investigator will coordinate with law enforcement agencies, including the Sheriff's Office, to investigate leads. The Investigator will have access to mobile technology needed to collect evidence directly or allow other agencies to collaborate with an investigation. The DA Investigator will regularly coordinate with the Deputy DA.

The 0.2 Department Analyst will work with the County's existing data systems to facilitate information sharing related to the investigation of organized retail theft crimes both within the county and with other counties and state-level agencies. The Department Analyst will ensure the creation and implementation of a specific case type that will be assigned to all retail theft cases when entered into the case management system. The Department Analyst will be assigned to review the data regarding organized retail theft crime post-investigation on a quarterly basis to identify investigations, cases charged and prosecuted, and metrics regarding the success of the program in meeting its identified objectives.

All three staff members will be provided with benefits that include County retirement, FICA, health insurance, HRA, LTDI, dental insurance, vision insurance, unemployment insurance,

The Sonoma County DA's Office incurs internal service charges related to each staff member. These charges represent the cost to the County of having an employee, and include: administrative services, liability insurance, basic computer charges, telephones, and the payroll system. The Deputy DA and DA Investigator will be hired during Year 1, and the DA's Office anticipates that they will provide approximately 1.8 months of work to the ORT VPU. In Years 2 and 3, the DA's Office is requesting only a fraction of the standard internal service charges: 4.8 months out of the year. The DA's Office will provide the rest of the cost of internal service charges to demonstrate its commitment to the project.

The DA Investigator requires an extensive onboarding process that includes a significant beground check, psychological evaluation, and the purchase of a firearm. The Chief Investigator will oversee this process using established County procedures. The background check totals \$2,000, the psychological evaluation totals \$774, and the firearm totals \$1,220. However, The DA's Office is only requesting BSCC funds to cover the cost of the background check as a demonstration of its commitment to the project.



Memorandum of Understanding (MOU) Between Petaluma Police Department And Sonoma County District Attorney's Office

This Memorandum of Understanding (MOU) is made and entered into on this [Date] between the Petaluma Police Department ("PPD") and the Sonoma County District Attorney's Office ("SCDA") to establish a cooperative partnership in investigating and prosecuting criminals conducting organized retail theft in our jurisdiction.

Purpose:

The purpose of this MOU is to facilitate collaboration and cooperation between the PPD and SCDA in addressing the issue of organized retail theft. By working together, we aim to effectively investigate, gather evidence, and prosecute individuals and groups involved in these criminal activities, thereby reducing the prevalence and impact of organized retail theft in our community.

Scope of Collaboration:

- a. Information Sharing: Both parties agree to exchange relevant and timely information pertaining to organized retail theft cases, including intelligence on criminal networks, suspect information, evidence collection, and case updates. - e. Community Outreach and Public Awareness: The PPD and SCDA will jointly engage in community outreach initiatives to raise public awareness about organized retail theft, its impacts, and the importance of reporting suspicious activities. By fostering a sense of shared

Confidentiality:

Both parties acknowledge the sensitive nature of the information shared under this MOU and agree to maintain strict confidentiality. Information exchanged shall be used solely for the purpose of investigating and prosecuting organized retail theft cases and shall not be disclosed to any third party without prior written consent from the other party, unless required by law.

Term and Termination:

This MOU shall come into effect on the date of its signing and remain in force for a period of four years. Either party may terminate this agreement by providing written notice of termination at least 30 days prior to the intended termination date.

Governing Law:
