 - ◆ \$341 Million Requested
- ◆ **138 moved forward for rating**
 - ◆ \$271 Million Requested
 - ◆ 20 Cities
 - ◆ 90 Community-based Organizations
 - ◆ 28 Small Scope CBOs
- ◆ **109 proposals funded**
 - ◆ 21 Cities (including Los Angeles)
 - ◆ 65 CBOs
 - ◆ 23 Small Scope CBOs
