EXPLANATION OF RESULTS

The following pages contain the Jail Profile Survey results for the third quarter of 2000. Page 1 contains the quarterly totals based upon the monthly and quarterly data submitted to us by the participating jurisdictions. Page 2 and 3 show the trend data for variables we have been tracking for the last ten years. The remainder of this page provides explanations and clarifications of the data presented.

Page 1

- Unless otherwise noted, "projected totals" are based upon the average per day for the variable in question. For example, there was an average of 75,076 inmates per day in local jails (excluding Type I's) during the three-month span of July to September 2000.
- For some variables, we did not receive data from all jurisdictions (except ADP which is complete). We compute the percentage of the ADP which were housed in the jurisdictions that did supply us with data. For example, 96% of the jurisdictions, representing 96% of the State's ADP, indicated the number of felony inmates in their facilities. We then projected what the statewide number of felony inmates would have been if we received felony inmate data from the counties that house the remaining 4% of the inmates.
- The number for "Bookings" is the average of the monthly totals for July, August and September.
- For the following variables, the numbers presented are the totals as of the mid-quarter (i.e., August 15, 2000): Pretrial Release, Early Release, 2 and 3 Strikes, Felony Warrants, Misdemeanor Warrants, Juveniles in Custody and Undocumented Aliens.
- Assaults is the total number of serious inmate assaults on staff (resulting in a crime report), statewide, during the third quarter of 2000.

Pages 2 and 3

- The data in the 10-Year Summary tables are based upon survey data which the Board has gathered since the early 1980's.
- Prior to 1995, yearly averages were reported to the Board on an annual basis. Yearly averages from 1996 on have been the average across the 12 calendar months. In 1995, the yearly figure reported is the fourth quarter average, since we do not have data from the first three quarters.

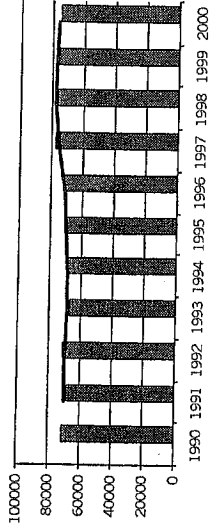

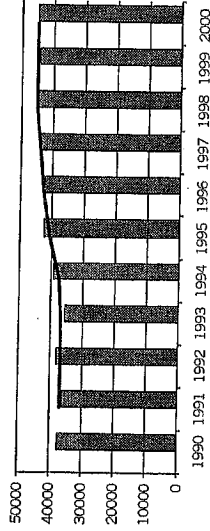


The ADP dropped by 500 from the last quarter of 1999 to the first quarter of 2000 to 75,070 inmates. A small increase of about 250 inmates occurred in the second quarter of 2000, but the ADP dropped back to 75,076 in the third quarter. These findings are consistent with the prediction we have made in previous reports that the ADP will continue to hover around the 75,000-inmate mark. This prediction is based upon the following: a) the Board Rated Capacity of the California jail system remains at approximately 71,000 beds; b) the number of persons given pretrial release or early release from their sentences is consistently over 15,000 individuals per month; and, c) the number of bookings has remained fairly stable over several years.

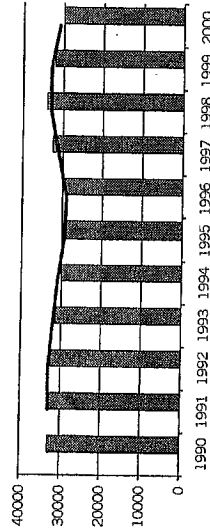


While the ADP has decreased by about 1,500 inmates since the first quarter of 1999, the Non-Sentenced ADP in that same time span had increased by about 700 inmates (from 44,087 to 44,746). When one considers that the fact that non-sentenced inmates are more expensive to house (because, for example, they require more staff resources related to court appearances), this increase in the non-sentenced population has significant cost implications.

During the same period that the non-sentenced population was increasing by about 700 (between the first quarter of 1999 and the third quarter of 2000), the sentenced population was decreasing by almost 2,200 inmates (a decrease from 32,480 to 30,311 inmates). Consistent with this decrease is the fact that approximately 11,000 inmates are released early from their sentences due to lack of bed space.

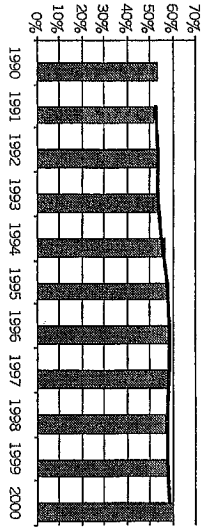

With non-sentenced populations increasing and sentenced populations decreasing, the percentage of inmates who are non-sentenced reached 61% for the first time in the first quarter of 2000. At present, non-sentenced inmates constitute 60% of the overall ADP. We expect that this percentage will gradually increase until more bed space is available.

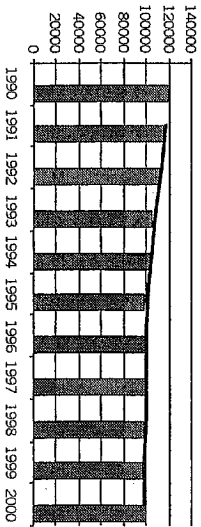


Average Number of Persons Booked Per Month

The number of persons booked per month increased to 101,528 in the third quarter of 2000. The number is slightly higher than the third quarter of 1999. It is also almost 5,000 higher than the first quarter of 1999. These numbers might suggest that the long expected increase in bookings (given the gradual decline from 120,000 per month in 1990 to the 96,834 per month in 1999) has begun.

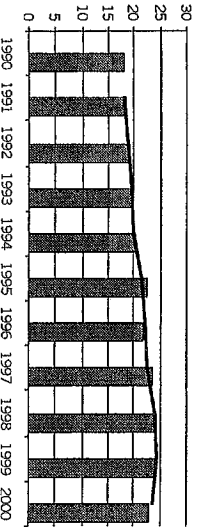

The Average Length of Stay was 17.9 days in 1990. For 1999, the Average Length of Stay was 24.0 days. For an ADP of 75,000 inmates to stay in jail an average of about 6 days longer in 1999 than in 1990 represents a huge increase in the demand for jail beds. Nevertheless, the number of available jail beds has not increased significantly since 1990. In 2000, the Average Length of Stay has dropped off somewhat to 22.7 days in the third quarter. This decrease could be the result of insufficient jail space, pretrial and early releases, and the increase in the number of bookings rather than any trend toward increased jail sentences.

JAIL POPULATIONS: 3rd Quarter '99 versus 3rd Quarter '00**

This table:

- summarizes the ADP results for the 64 jurisdictions in California reporting data from Type II, III, and IV jails;
- summarizes jurisdiction ADP results for the most recent quarter (Column B);
- compares jurisdiction ADP for the most recent quarter with the same quarter last year (Column A);
- ranks the jurisdictions in terms of gains or losses in ADP from high to low (Column C);
- lists the percentage growth or decline in ADP for each jurisdiction (Column D); lists the percentage of the overall State increase or decrease in ADP that is represented by each jurisdiction (Column E);
- lists, by jurisdiction, the cumulative percentage increase and decrease in the State ADP starting with the jurisdiction with the highest percentage of the increase and proceeding to the jurisdiction with the highest percentage of the decrease (Column F);
- lists, by jurisdiction, the cumulative total increase and decrease in the State ADP starting with the jurisdiction with the highest increase and proceeding to the jurisdiction with the biggest decrease (Column G); and,
- lists the jurisdictions that experienced decreases in their ADP as shaded.

Some important conclusions from this table are:

1. The two numbers at the bottom indicate the "total increase" in ADP (1,488) and "total decrease" in ADP (3,342). In other words, the jurisdictions experiencing increases had a total increase of 1,488 ADP; and the jurisdictions experiencing decreases had a total decrease of 3,342 ADP. Subtracting 1,488 from 3,342 produces the overall decrease of 1,854 between the third quarter of 1999 and the third quarter of 2000.
2. The Contra Costa ADP increase of 175 is 11.8% of the total increase of 1,488. Thirty-one jurisdictions had increases (down to Sierra Sheriff's Department). When you get to Sierra Sheriff's Department, you have accounted for 100% of the increases (100% of the cumulative total of 1,488). Two counties (Plumas and Riverside) showed no change in their ADP in comparing the 3rd quarter of 1999 to the 3rd quarter 2000.
3. Jurisdictions that experienced a decrease in ADP are listed from smallest decrease to largest decrease (Madera Corrections Department to Los Angeles Sheriff's Department). When you get to the bottom of the table, you have accounted for 100% of the total decreases of 3,342 inmates.
4. The cumulative percentage of ADP increase for the top four jurisdictions (Contra Costa Sheriff's Department to San Bernardino Sheriff's Department) is 36.29%. In other words, four jurisdictions accounted for about 36% of the total ADP increase. Three counties (Santa Clara DOC, San Francisco, and Los Angeles) account for about 62% of the decreases.
